VI. New Business

A. Review and action on Ethics Commission's Resolution No. 75640 and San Josè Municipal Code Chapter 12.04.

<u>Documents Filed</u>: 1) Ethics Commission Resolution No. 75640; 2) San Josè Municipal Code Chapter 12.04; 3) Administrative/Resolution Revisions Chart; 4) Memo from City Clerk Toni J. Taber to the Ethics Commission dated July 3, 2013 regarding Title 12 Amendments; and 5) Ordinance No. 29310.

<u>Discussion</u>: City Clerk Toni Taber reviewed the documents filed with the Commission and solicited revisions and feedback from the Commissioners. The Commissioners agreed that the name of the Commission needs be changed through the Resolution and Municipal Code and that both should clearly state what is and is not in the purview and jurisdiction of the Commission.

Chair Michael Smith requested that the Commissioners review Resolution No. 75640 and the San Josè Municipal Code Chapter 12.04 and send revisions and suggestions directly the the City Clerk staff for amendment. City Clerk Toni Taber will bring revised drafts of both documents to the next meeting for review by the Commission.

Commissioner Linda Edgeworth requested that the collection of fines and schedule of fees be added back to the Administrative/Resolution Revisions Chart even if these changes will not be made until a future date.

<u>Discussion</u>: City Clerk Toni Taber reviewed the draft Ethics Commission Complaint Form with the Commission. The Commission requested changes to the Complaint Form (i.e. adding City Clerk e-mail to form, changing meeting date, adding notation that Complaints are for the City of San Josè campaigns only, etc.) City Clerk Toni Taber will revise Complaint Form and will bring back to Commission at the next meeting for review.

C. Review and action regarding proposed revisions to Chapter 12.06 of the San Josè Municipal Code related to the Office/Candidate Legal Defense Fund..

<u>Document Filed</u>: Memo to from City Attorney Richard Doyle to the Rules and Open Government Committee dated October 22, 2013 regarding Proposed Revisions to Chapter 12.06 of the San Josè Municipal Code Related to the Officeholder/Candidate Legal Defense Fund.

<u>Discussion</u>: City Clerk Toni Taber reviewed the memo from City Attorney Richard Doyle with the Commission and explained that the Mayor's Office would like to approve an ordinance amending Chapter 12.06 of the San Josè Municipal Code to allow City Council members to establish legal defense funds to defend themselves against administrative or legal proceedings. The Municipal Code currently prohibits officeholder accounts.

The Commission discussed the memo and requested that the City Clerk seek clarification from the City Attorney on the following questions:

1) If passed, who would monitor the officeholder accounts;

2) What role would the City Clerk's Office and the Ethics Commission play in monitoring or policing the officeholder accounts?; and

3) Do the requirements listed in the memo apply to campaign committees?

The Commission would like a status report on this item given at the next Commission meeting.
