

## NOTICE OF HEARINGS & MEETINGS FOR A SUBSTANTIAL AMENDMENT TO THE FY 2016-2017 ANNUAL ACTION PLAN

THE CITY OF SAN JOSE WILL, IN JANUARY 2017, CONSIDER CHANGES TO THE PREVIOUSLY ADOPTED FISCAL YEAR (FY) 2016-2017 ANNUAL ACTION PLAN. THIS NOTICE PROVIDES A SCHEDULE OF HEARINGS AND OPPORTUNITIES FOR PUBLIC COMMENT DURING THIS PROCESS.

The Annual Action Plan (AAP) outlines the City's housing and community development needs, and provides a one-year action plan on how the City intends to use its federal funds to address those needs. The proposed Substantial Amendment would make the following changes to the FY 2016-17 AAP: (1) Allocate Community Development Block Grant (CDBG) funds for the acquisition of property for the development of permanent supportive housing for formerly homeless households; and (2) Allocate Emergency Solutions Grant (ESG) Funds, not expended in the previous fiscal year, to support services for homeless individuals and families. The City's Citizen Participation Plan requires public noticing and an opportunity for public comment when an amendment includes a change in funding of \$100,000 or 25%, a significant change to the beneficiaries of an activity, or the funding of a new activity. The proposed changes meet this threshold.
