



**NOTICE OF PUBLIC HEARINGS & MEETINGS FOR A  
SUBSTANTIAL AMENDMENT TO THE FY 2017-2018 ANNUAL ACTION PLAN**

**THE CITY OF SAN JOSÉ IS DEVELOPING A SUBSTANTIAL AMENDMENT TO ITS 2017-2018 ANNUAL ACTION PLAN (AAP). THIS NOTICE PROVIDES A SCHEDULE OF PUBLIC HEARINGS AND OPPORTUNITIES FOR PUBLIC COMMENT.**

The proposed Substantial Amendment provides updates to the City’s approved 2017-2018 Annual Action Plan (AAP), which governs the use of federal funds from the U.S. Department of Housing and Urban Development. These funds, which include Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), HOME Investment Partnerships (HOME), and Housing Opportunities for Persons with AIDS (HOPWA), average approximately \$12 million annually depending on the federal budget. The development of these Plans is significantly informed by public feedback.

If you would like to provide comments on the Draft Substantial Amendment to the FY 2017-2018 Annual Action Plan, the City welcomes your attendance at any of the meetings listed in the schedule below.
