- 2. <u>Discussion and Action on the Draft 2015-16 Neighborhoods Commission Work</u> <u>Plan</u>

The Commission discussed and agreed on the Commission's mandatory tasks as set by Council: Prepare for and hold Caucuses for Commission seats (November and May); Review and provide input on the Mayor's Budget Message (February-April); and Develop the 2016-2017 Commission workplan (June).

The Commission discussed other items to add to the workplan and voted item-by-item. The top vote-getters were as follows (with Commissioners who volunteered to lead the effort for the item):

- Illegal Dumping and Blight Prevention: 15 votes (Desiree Barragian, Dan Keller, Moses Ramirez, Joe Horwedel, Pete Kolstad & Robert Sandoval) Illegal Fireworks: 13 votes (Nick Labosky, Desiree Barragan, Nichole Edraos, Dan Keller, Joe Horwedel, & public member Janice Rombeck)
- Develop Community Input: 11 votes (Matt Whalin, Terry Martin, Pete Kolstad, Nichole Edraos & Marie Arnold)
- Homelessness: 10 votes (Norma Callendar, Richard Giammona, Moses Ramirez,
- Linda Locke)
- Police Body-Cameras: 9 votes (Note: Update from Police Department to be scheduled in November, no subcommittee work)
- Work Plan Product: 8 votes (Gary Cunningham, Nichole Edraos, Pete Kolstad & Norma Callendar)
- Involvement of City Auditor: 8 votes (Norma Callendar, David Dearborn, Terry Martin & Gary Cunningham)
- Police Deployment & Strategies; Gang & Crime Prevention: 7 votes (Juan Estrada offers to lead & Nick Labosky to serve)

The Commission moved that the Chair, Vice Chair, and Staff get together before the September 9, 2015 Commission meeting to develop a monthly schedule for the above topics. **Motion passed unanimously.**

3. <u>Discussion and Action on Process for Inclusion of Items on Commission Agendas by</u> <u>Commissioners and Requests from the Public.</u>

Due to time constraints, the Commission discussed this item briefly and agreed to return in September to review more thoroughly. Commissioners David Dearborn and Nichole Edraos shared a draft document outlining their thoughts on a proposed Commission Work Process.
