SAP Center at San Jose. Planning for the National Football League's Opening Night at SAP Center at San Jose is near completion. The event is scheduled for February 1<sup>st</sup> and 3,000 national and international media representatives are expected to attend. Portions of the Bus Rapid Transit eastbound station have been installed. Work on the westbound station is being postponed until early February due to the NFL event. There has been preliminary discussion about changing the construction sequence for the San Jose portion of the High Speed Rail project.
