1. <u>Call to Order/Roll Call/Introductions</u>. The Arena Authority convened the Regular Meeting of the Board of Directors at SAP Center at San Jose at 4:04 pm. Noelle Vergara has resigned her position with the Arena Authority Board due to a relocation out of the area.

#### 2. General Business

- a. <u>Welcome New Arena Authority Board Members Scott Bruner, Sarah Finn,</u>
  <u>Vinni Walia, and Rusty Weekes</u>. The Arena Authority welcomed four new At-Large Arena Authority Board members.
- b. <u>Accept Report on Legal Requirements for Board Members (Klotz)</u>. Elizabeth Klotz, City Attorney, presented Brown Act, City of San Jose Sunshine Reporting Requirements, and Conflict of Interest training to the Arena Authority Board.
- c. <u>Review and Approve August 2016 Board Meeting Minutes</u>. Approved. 8 Approvals, 5 Abstentions (Bruner, Finn, Terrazas, Walia, Weekes).

# 3. <u>Executive Director and Staff Reports</u>

#### 3.1. Executive Director (Morrisey)

- a. Accept Verbal Reports on Arena Authority Oversight
  - <u>SAP Center at San Jose</u>. Capital projects in the vicinity of the Center include the repaving of Santa Clara Street east of Route 87, the realignment of Julian Street east of Route 87, and the creation of a BART project contact list.

The City Manger's Office liaison has volunteered to provide updates to the Board on capital projects in the vicinity of SAP Center at San Jose, including BART, High Speed Rail, the Diridon multimodal station, and the vicinity parking inventories. Outdoor events in the vicinity of the Center continue to be coordinated with the City's Office of Cultural Affairs.

- <u>Sharks Ice at San Jose</u>. The City Council approved a new naming rights agreement for Sharks Ice at San Jose. The new name of the facility will be Solar4America Ice at San Jose.
- <u>San Jose Municipal Stadium</u>. Work on the stadium sewer lines is anticipated to begin in early November. Capital budget discussions for FY 2017-18 are currently underway.
- b. <u>Accept Verbal Reports on Arena Authority Administrative Issues</u>
  - <u>City Council Representative</u>. No report.
  - <u>South Campus Operations Team</u>. Construction has begun for the new golfing facility at San Jose State University. The track, which is used for event parking in the south campus area, is currently accessible for Municipal Stadium events.

# 3.2. Administrative Assistant (Wang)

- a. Accept Report on Recent and Upcoming Events at SAP Center at San Jose. The San Jose Sharks season home opener takes place on October 12. The San Jose Barracuda season home opener takes place on October 28. An Arena Authority Board member expressed concern that events similar to an upcoming event (Five Finger Death Punch) may condone aggressive physical behavior. Executive Director Morrisey will engage representatives from SAP Center Management to discuss the matter.
- b. <u>Accept Verbal Report on Activities at Sharks Ice at San Jose</u>. The San Jose Barracuda will play two exhibition hockey games at Sharks Ice at San Jose on October 6 and 9. Sharks Ice at San Jose to host Ice Dance Weekend October 7-9. Sharks training camp started on September 23.
- c. <u>Accept Verbal Report on Submittal of Arena Ticket Distribution Program Report for FY 2015-16</u>. Although no longer obligated per City Council policy, Arena Authority staff will soon forward the FY 2015-16 Arena Ticket Distribution Program report to the City Manager's Office for distribution to the City Council.
