Deputy City Manager Norberto Duenas, Sergeant Todd Trayer, Vice Unit, and Lieutenant Mike Sullivan offered background information, provided an update, and answered questions from the Committee. City Attorney Richard Doyle provided additional background and answered questions.

Councilmember Liccardo voiced additional comments and encouraged the Committee to refer discussion to the City Council Closed Session on October 7, 2014.

David Wall opined on various solutions to the issue.

(2) Affordable Housing and Homeless Housing Funding Source. (Mayor)

Place the following on the City Council agenda for October 7, 2014: Direct the City Manager and the City Attorney to engage in settlement discussions with the County of Santa Clara to resolve an existing dispute over the City/County Pass-through Agreement, with a new agreement to use all the funds in dispute (approximately \$20 million per year) for affordable housing (50%) and housing for the homeless (50%). [Rescheduled from September 24, 2014 – Item G(2)]

The Committee emphasized the need to respond to questions posed in a letter from the BIA, do the work necessary to be legally defensible, and set aside enough time for Council deliberation and get all staff work to the Council ahead of the meeting.

Director of Housing Lesley Corsiglia answered questions from the Committee.
