RULES COMMITTEE REVIEWS, RECOMMENDATIONS AND APPROVALS

(3) Police Recruits. (Mayor)

- a. Place the following matters on the City Council agenda for November 4, 2014:
 - 1. Appointment of an independent investigator to investigate the recruiting, hiring and training process for the last three police academies to determine:
 - If city employees have engaged in improper activities to suppress the number of new officers joining the San Jose Police Department and to induce new officers to leave the department while in training;
 - If improper activities took place on city-paid time, used city facilities or communication systems;
 - If allegations about statements made to the current academy class by the president of the Police Officers' Association, as alleged by Elyse Rivas, in the San Jose Mercury News, October 19, 2014, p.A19, are true;
 - If the alleged statements, which were made to the academy class during an official city training program, violated the California laws prohibiting the use of city resources for campaign activity; and
 - If any other laws, ethical codes, or city policies have been violated by city employees in the recruiting, hiring and training process.
 - 2. Appointment of a City Council Ad Hoc Committee to manage the investigation until the results are brought back to the full Council for review and action.
- b. Direct the City Attorney to put all city employees on notice of an investigation hold on documents to prevent the deletion or destruction of any records potentially relevant to the investigation and to be prepared to recommend an investigator to the Council on November 4, 2014.
- c. Discuss and make recommendations to the City Council regarding the scope, methodology and procedures for the investigation and for the Ad Hoc Council Committee process and membership.

Mayor Reed offered background and additional comments related to his memorandum. He noted revisions to the recommendation clarifying what should be investigated. The recommendation was revised to read:

- 1) Appoint an independent investigator to investigate the recruiting, hiring and training process for the last three police academies to determine if actions have been taken during the process to reduce the number of new officers joining the San José Police Department or to induce new officers to leave the department while in training;
- 2) Appoint an ad hoc committee to monitor the investigation until the results are brought back to the City Council for review and action.

(3) Councilmember Constant requested a slight modification to the recommendation to change part 1 from "while in training" to "while in the academy, field training program, or probationary period."

Committee discussion ensued and City Attorney Richard Doyle answered questions from the Committee.

Public Comment:

David Wall expressed objections to the recommendation. Martha O'Connell spoke in support of an investigation.

Mayor Reed offered additional clarification relating to his memorandum.

<u>Motion</u>: Councilmember Constant moved to forward the recommendation to the November 4, 2014 City Council Agenda including the following revisions:

- 1) Appoint an independent investigator to investigate the recruiting, hiring and training process for the last three police academies to determine if actions have been taken during the process to reduce the number of new officers joining the San José Police Department or to induce new officers to leave the department while in the academy, field training program, or probationary period;
- 2) Appoint an ad hoc committee to monitor the investigation until the results are brought back to the City Council for review and action.

Vice Mayor Nguyen seconded the motion.

Councilmember Oliverio requested the motion be amended to be heard on the <u>November 7, 2014</u> special meeting agenda, and Item (1) on the November 7, 2014 special meeting agenda be deferred to <u>November 18, 2014</u>. Councilmember Constant accepted the amendement.

Action: Upon a call for the motion, it carried unanimously. (4-0.)
