# RULES COMMITTEE REVIEWS, RECOMMENDATIONS AND APPROVALS (CONT'D)

## (2) Patrol Staffing Retention Plan. (Mayor/Liccardo/Khamis)

Place the following item on the City Council agenda for <u>September 16, 2014</u>: Direct the City Manager to begin negotiations with the Police Officers Association and other applicable bargaining units to:

- Enter into a stipulation to defer the implementation of the portion of Measure B that calls for our employees to make an additional 4% contribution of salary to the Police & Fire and Federated retirement plans or take 4% reduction in pay, for at least an additional year beyond July 1, 2015, the expiration of our existing stipulation.
- b. Create a Patrol Staffing Retention Plan to allow officers with 25 years or more of experience to remain in a paid position on the force, in patrol, while receiving a distribution of pension benefits in some form. Such a program must avoid the large liabilities created by guaranteed rates of return in many "DROP" programs, and ensure that officers who remain on the force do so at a rank of officer or sergeant, serving in a patrol responsibility.

<u>Documents Filed</u>: Memorandum from Mayor Chuck Reed, and Councilmembers Sam Liccardo and Johnny Khamis, dated September 4, 2014, entitled "Patrol Staffing Retention Plan."

<u>Public Comment</u>: David Wall opined on Police & Fire Benefits and pay.

<u>Action</u>: Upon motion by Councilmember Oliverio, seconded by Vice Mayor Nguyen and carried unanimously, the recommendation was approved and placed on the <u>September 16</u>, 2014 City Council agenda for action. (4-0.)

## (3) Order to Show Cause for 801 N. 13th Street. (Liccardo)

Direct the City Manager to initiate the process to issue an Order to Show Cause, pursuant to Muni Code Section 20.150.220, for the property located at 801 N. 13th Street as to why it should not lose its Legal Non-Conforming (LNC) status as a bar.

City Attorney Rick Doyle answered questions from the Committee and provided background information on how the process is conducted.

<u>Public Comment</u>: Larry Yamasaki, Jose Posadas, Stephen Gordy, Katrina Loera, Luna Park Business Association, David Wall, David Bird, Trinity Cathedral, Hung Dang, Guadalupe Yanez, Irma Marfil, Carol Garvey, Riko Mendez, Tomas Marfil, Susan Caballero, Elisa Hwang-Mendez, Sharon Marfil, Rebeca Armendariz, Cassie Kifer, Kirsty Duncan, and Rev. Dr. Lee Barford, Trinity Cathedral, spoke in support of the recommendation and urged the City to take action.

# RULES COMMITTEE REVIEWS, RECOMMENDATIONS AND APPROVALS (CONT'D)

(3) Riko Mendez submitted letters in support of the recommendation and a flash drive featuring pictures and video of the acts in question.

Deputy District Attorney Johnny Gogo spoke on behalf of the Santa Clara County District Attorney's Office in support of the recommendation and answered questions from the Committee.

City Attorney Rick Doyle, City Manager Ed Shikada, Deputy City Manager Norberto Duenas, Director of PBCE Harry Freitas offered background information and answered questions from staff.

Councilmember Liccardo was available for additional information and requested action be taken quickly.

Committee discussion ensued.

<u>Action</u>: Upon motion by Councilmember Constant, seconded by Vice Mayor Nguyen, and carried unanimously, the recommendations were referred to staff and directed to return to the Rules and Open Government Committee in two weeks. (4-0.)
