Deputy City Manager Kip Harkness, provided an introduction; Transportation Assistant Director Kevin O'Connor and Innovation Program Manager Jill North provided a presentation and responded to questions.

Mayor Sam Liccardo expressed concern about DMV regulations and Federal legislation, which are anticipated to preempt some Local and State regulations in ways that are estimated to move quickly.

Councilmember Chappie Jones expressed concern about the City's goals and wondered if there were specific metrics against which to measure the success of the pilot project.

Mayor Sam Liccardo commended to his team. and expressed gratitude for the great team spirit in helping to defeat SB-649, (a California Assembly Bill easing permits on cell phone towers); and sought answers on the question of AB-1665, (California Assembly Bill with the moniker, "California Needs Internet for All Now!", or the Internet for All Now Act AB1665) signed by the Governor recently and SB-802, (California Senate Bill or Emerging Vehicle Technology: Advisory Study Group.)
