<u>Documents Filed</u>: Supplemental memorandum from Chief Financial Officer Julia H. Cooper, dated September 29, 2015, providing additional information and validation of the methodology used to determine the reserve amount (Line #1 on the ROPS).

Chief Financial Officer Julia H. Cooper presented the supplemental memorandum and recommended approval of the ROPS. Finance Staff responded to questions from the Board.

Motion: Board Member Guthrie moved approval of the ROPS with revisions to show four lines for the different components of the Allowable Bond Reserve (Line #1) and Lines #249, #250 and #251, with authorization of payment of expenditures for items on ROPS 15-16B, detailing the obligations of the Successor Agency for the period of January 1, 2016 through June 30, 2016, and determine another provision for the remaining six months during a broader discussion before it is approved in January 2016. Board Member Andrade seconded the motion.

Board Member Snow expressed dissatisfaction with the methodology as presented and a desire to have a greater understanding of anticipated revenues.

Action: On a call for the question, the motion carried, and Resolution No. 2015-10-1094, entitled "A Resolution of the Oversight Board of the Successor Agency to the Redevelopment Agency of the City of San José Approving the Recognized Obligation Payment Schedule 15-16B and Authorizing Payment of Expenditures for Items on ROPS 15-16B, which Details the Obligations of the Successor Agency for the Period of January 1, 2016 through June 30, 2016", was adopted. (5-1-1. Noes: Snow. Absent: Maduli.)

## B. Approve the use of "Other Funds" Required to Pay for 14-15B Obligations

Motion: Board Member Shannon moved approval with lines eliminated from the Reimbursement Agreement that reflect the prior period adjustments for ROPS 14-15B. Board Member Snow seconded the motion.

Action: On a call for the question, the motion carried unanimously, and Resolution No. 2015-10-1095, entitled "A Resolution of the Oversight Board of the Successor Agency to the Redevelopment Agency of the City of San José Approving the Use of "Other Funds" to Pay for Recognized Obligations Payment Schedule 14-15B Obligations Due to an Insufficiency of Redevelopment Property Tax Trust Funds", was adopted. (6-0-1. Absent: Maduli.)
