Successor Agency Managing Director Richard A. Keit provided Staffs' recommendations and responded to questions from the Board.

<u>Action</u>: Upon motion by Board Member Estremera, seconded by Board Member Guthrie the motion carried unanimously, and <u>Oversight Board Resolution No. 2014-01-</u><u>1058</u>, entitled "A Resolution of the Oversight Board of the Successor Agency to the Redevelopment Agency of the City Of San José Approving the Transfer of the Circle of Palms Property as a Governmental Purpose Property from the Successor Agency to the City of San José in Accordance with Health and Safety Code Section 34181(A)", was adopted. (6-0-1. Absent: Reed.)

### 6.2 Long-Range Property Management Plan (LRPMP)

### Item 6.2 was heard following Items 6.3 and 6.4 to allow for participation by Chair Reed.

<u>Documents Filed</u>: (1) Memorandum from Executive Officer Ed Shikada, dated December 20, 2013, recommending review and discussion of the Draft Long Range Property Management Plan and direction to Successor Agency Staff. Successor Agency Managing Director Richard A. Keit provided an overview of the Plan.

<u>Public Comments</u>: (1) Marne S. Sussman, representing Stand for San José, referenced the Diridon Properties, submitting they do not believe the obligation with the option agreement to AIG is enforceable under the law, and the Oversight Board has the duty to reject the plan; and, additionally, that the Oversight Board should request an updated appraisal for these properties. (2) Mark Marson addressed use of Property #18, 1343 The Alameda, Hanchett Parking Lot, citing its potential in revitalizing The Alameda and interest in raising money for park conversion.

Extensive discussion of the Long-Range Property Management Plan ensued, with a property-by-property review and Staff response to questions from the Board. Property #1 through Properties #60-64 were reviewed, with discussion to be continued at the January 30, 2014 meeting of the Oversight Board.
