Adoption of a resolution_approving the determination that the amount of Nonhousing cash and cash equivalents that are available for disbursement to taxing entities as determined according to the methods provided in Health and Safety Code Section 34179.5 is \$0, and directing Successor Agency staff to forward such determination to the State Department of Finance and the Santa Clara County Auditor-Controller.
