Rachel Vanderveen, Administrative Officer, Finance Department, provided an overview, and she and Senior Deputy City Attorney Tom Murtha responded to questions from the Board.

<u>Motion</u>: Board Member Guthrie moved approval of the staff's recommendations, with an amendment making the Long Term Reimbursement Agreement only remain in effect through December 31, 2014. The motion was seconded by Board Member Snow.
