# Regular Meeting Minutes Tuesday, June 21, 2016

#### a) CALL TO ORDER

## d) CHAIR'S REPORT - Tina Morrill

- 1. Chair reported that \$3 million in Airport public art funding has been deferred indefinitely, until passenger traffic reaches threshold of 12.2 million. Arts Commission created an Ad Hoc Committee consisting of herself with Arts Commissioners Lynne Brown, Roma Dawson and Ramona Snyder to examine this further; it will meet and report back to the Arts Commission.
- 2. Happy Hollow Park & Zoo made presentation at last night's Arts Commission meeting. Noted that while not an arts organization, art and art projects are everywhere in their public spaces.
- 3. Thanked the PAC, PAAC and staff for their service, noting that this is the last meeting of FY 2015-16 and committee changes will come with the new fiscal year.

#### e) ACTION & DISCUSSION ITEMS

#### 1. COMMUNITY PROJECTS

a. Report: Artworks along Lincoln Avenue, a project of the Willow Glen Business
Association and the District 6 Council Office (Council District 6)
L. Rogers reported on the art projects along Lincoln Avenue, funded by the District 6
Council Office in collaboration with Willow Glen Business Association. Six of seven
murals have been completed; six sculptures, three each by local artists Mike Gustavson
and Jeff Owen, will be installed in August; a project for crosswalk art is to take place in
the fall months.

#### 2. DESIGN DEVELOPMENT

  - a. M. Rubin reported on the project with Live Silicon Valley for the County's upgrade to the Valley Medical Center. SJPA is providing project management services to the project.
  - b. L. Rogers reported that SJPA is part of a collaborative ACHS grant application with the Housing, Transportation and Parks Departments for development in the area of Coleman and Bassett Avenues; if awarded the public art project would include underpass lighting that connects to the nearby park space.
