# DIRECTIONS TO ROOSEVELT COMMUNITY CENTER

#### Address

901 East Santa Clara Street (access parking lot from N. 21st Street) San José, CA 95116

## **Directions from US Highway 101**

- 1) Exit 386A, E. Santa Clara Street/Alum Rock Ave.
- 2) Drive west on Santa Clara Street for 0.6 miles. Destination will be on the right.

### **Driving from Highway 280 South**

- 1) Follow I-280 S to S 11<sup>th</sup> Street.
- 2) Take the 10<sup>th</sup> Street exit.
- 3) Continue on S 11<sup>th</sup> Street for 1.0 mile.
- 4) Turn right onto E Santa Clara Street and drive 0.5 miles. Destination will be on the left.

#### **Driving from Highway 680 South**

- 1. Merge onto US-101 N toward San Francisco using the right 3 lanes of I-680 S.
- 2. Take the Alum Rock Ave/California 130 exit toward Santa Clara Street.
- 3. Drive west on Santa Clara Street for 0.6 miles. Destination will be on the right.
