Program Timeline

- **June 17, 2014:** Council Approved Medical Marijuana Program
- **December 18, 2015:** Deadline for Collectives to Register Under the Approved Program
 - Sixteen (16) Collectives Registered
 - Each Collective serves anywhere from several hundred to upwards of 20,000 individuals per month

WHERE?

Zoning Districts

Allowed In:

- Downtown Primary Commercial
- Combined Industrial/Commercial
- Industrial Park
- Light Industrial
- Heavy Industrial

“Sensitive Use” Buffers

Not Allowed Within:

- **1,000 feet of:** schools, daycares, community centers, parks or libraries
- **500 feet of:** substance abuse rehab facilities or emergency residential shelters
- **150 feet of:** places of religious assembly, adult care facilities, or residential uses *
- **50 feet of:** another Collective *

**Measured parcel line to parcel line*

HOW?

Vertical Integration

- Each Collective can dispense in San José marijuana and marijuana infused products the Collective grows and manufactures
- Each Collective can grow and manufacture in the City, in Santa Clara County, and in any one of the neighboring counties
- San José Collectives that are registered may exchange marijuana and marijuana infused products with each other

3rd Party Transactions

- Collectives doing business with other marijuana growers and manufacturers throughout California
 - Allows a Collective registered in San José to dispense in San José any marijuana or marijuana infused product (ie., brownies, candy, drinks, oils, concentrates, wax...) the Collective gets from another grower or manufacturer operating anywhere in California.
 - Also allows a Collective registered in San José to provide its own marijuana and marijuana infused products to other growers and manufacturers operating anywhere in California.

Secondary / Multiple Locations

- Collectives growing & manufacturing marijuana from more than one location
 - Allows Collectives registered in San José to grow marijuana and manufacture marijuana infused products from more than one location.

Grow Operations Statewide

- Collectives growing marijuana anywhere in California
 - Allows Collectives registered in San José to dispense in San José marijuana that the Collective grows outside of San José or grows anywhere in California.

Sharing Grow Sites

- Collectives sharing their marijuana grow sites
 - Allows Collectives registered in San José to share marijuana grow sites with other Collectives registered in San José.

No Buffer Between Growing/Manufacturing Sites

- Removing the 50 foot buffer required between Collective sites where growing and manufacturing is occurring
 - Gets rid of the 50 foot buffer that Collectives are currently required to keep between their marijuana growing/manufacturing sites so that in San José multiple Collectives could grow and manufacture right next to each other.

Greenhouse Grows

- Collectives growing marijuana in greenhouses in San José
 - Allows Collectives registered in San José to grow marijuana from greenhouses in San José.
