If staff determine that review by other divisions is necessary, additional referral fees will apply as outlined in the Building Fee Schedule.

NO APPOINTMENT REQUIRED. Submit the application package in person at the Development Services Permit Center, 1st floor, City Hall.

SECTION A. PLAN SUBMITTAL AND REVIEW

Complete and accurate sets of plans and calculations for the entire building must be submitted for review before a Foundation-Only Permit can be considered; the foundation and superstructure are considered as a single project review. The City plan reviewer may request corrections to the plans, for foundation and building alike, as well as determine the need for clearances or other permits before the Foundation-Only Permit will be considered and approved. The following items must be included in the project plans:

- 1. Cover Sheet Describe and specify all aspects of the foundation-only construction in a Scope of Work statement. Include any work for a garage, any subterranean structural slabs or walls, etc.
- 2. Site Plan and Floor Plans
 - Include all property lines and any recorded easements on the Site Plan.
 - Provide complete floor plans for all levels above the foundation; identify these floor plans as "For Reference Only."
 - Other detailed drawing sheets may be labelled "For Reference Only" or denoted as "Omitted."
- 3. Foundation Drawings & Calculations
 - Include all electrical, plumbing, and other trade work associated with the foundation.
 - Provide relevant details reflecting the descriptions in the Scope of Work.
 - Provide all applicable loads for each element of the foundation, including vertical, lateral, and overturning. This includes at each spread footing, wall, holdown anchor, etc.
 - Provide calculations for the design of each element of the foundation.

SECTION B. REQUIRED CLEARANCES AND OTHER PERMITS

Based upon review of your plans, the City plan reviewer will determine what clearances or other permits are required prior to issuance of a Foundation-Only Permit.
