Dear Bill:

The City is in receipt of your letter dated April 20, 2012, regarding the City's Last, Best, and Final Offer on Healthcare, Medicare Part A and B, and Pension Benefits for New Employees. We would like to acknowledge that OE#3 has "conceptually agreed" to the proposed Pension Benefits for New Employees, and greatly appreciate your organization's acceptance of the proposal. However, we disagree with your assertion that we have not discussed the details of the plan in bargaining. The City engaged OE#3 in negotiations over these issues, and has offered various specific proposals on these matters since last year.
