



Welcome to Your Neighborhood Park

This Neighborhood Park is shared public space provided for your enjoyment and recreation. Please have a fun and safe visit. Be courteous and respectful to others and please keep the park clean.

This park closes one hour after sunset and opens at sunrise.

Park Rules Prohibit:

- 1. Engaging in Commercial Activity Except by Permit
- 2. Vehicles Without Specific Authorization
- 3. Performing, Entertaining or Exhibiting Except by Permit
- 4. Amplified Sound Except by Permit
- 5. Feeding of or Tampering With Wildlife
- 6. Using Illegal Drugs, Alcohol or Smoking
- 7. Guns, Dangerous Instruments and Fireworks
- 8. Vandalism to City Property such as Graffiti, Tagging, Burning, Carving
- 9. Littering, Unauthorized Dumping or Dumping of Residential Garbage
- 10. Entering Park after Closing
- 11. Use of "Air Jumpers", "Bounce Houses" or "Inflatable Houses" Except by Permit in Designated Areas
- 12. Dogs Off Leash Except in Designated Areas Where Posted
- 13. Outdoor Fires Except in Designated Areas
- 14. Powered Model Airplanes, Boats, Cars, Rockets, Motorized Scooters
- 15. Food and Clothing Distribution
- 16. Skateboarding, Roller-Skating and In–Line Skating on Park Structures, Furniture or Hard Courts
- 17. Organized Sports Except in Designated Areas
- 18. Camping in Public Parks or Park Lands
- 19. Golf or Practice of Golf
- 20. Overnight Parking in Parking Lots
- 21. Tampering with Pest/Bait Stations

Neighborhood Park Picnic Reservations ADDITIONAL RULES & REGULATIONS

OPERATING HOURS: Open year-round from 8:00 a.m. to one-half hour after sunset. Please follow all posted signs in the park.

<u>PARKING</u>: Parking is available as designated by all posted parking regulations in or near parks.

<u>AMENITIES</u>: Vary by individual park. For additional information call (408) 794-PARK [794-7275] or visit the website at http://www.siparks.org/parksdirectory.asp

<u>VEHICLE ACCESS</u>: Vehicles are not allowed within the park, its service roads or paths. Vehicles driving within the park are subject to citation and may be towed at owner's expense.

RESTROOMS: Restrooms open 9:00 a.m. to sunset during summer season. Winter season schedule varies and is posted at each site.

PHOTO PERMITS: Photo permits are required for all commercial photo shoots. This includes professional wedding photographers. Permits can be obtained at Leininger Center, 1300 Senter Road, San José, CA 95112.

GENERAL RULES:

- 1. Amplified sound including drums and loud radios are prohibited.
- 2. Alcohol is not allowed in Neighborhood Parks.
- 3. Ponies and other large animals are not allowed.
- 4. Dogs must be on a leash. Each park may be posted with individual rules specific to an area in the park.
- 5. Additional tables and chairs from outside of the park are not allowed.
- 6. Air jumpers are only allowed with a permit at certain parks.
- 7. Smoking is not allowed in City of San José Parks.
- 8. All San José Municipal Codes and State Laws apply.

CHANGES OR CANCELLATIONS: Reservations may be changed in writing (date or location) at applicant's request. The cost for this change will be \$20.00 and plus/minus the difference in site rental fees. Note also Rules and Regulations 8.A. Cancellations must be requested in writing and submitted in person at Leininger Center. Refunds will be mailed to the address on the receipt 6-8 weeks following the date of cancellation or the event date. Refunds will be issued for

- Cancellations requested more than 30 calendar days prior to reservation date minus a 25% cancellation fee.
- Cancellations requested 30 calendar days or less prior to reservation date minus a 50% cancellation fee.
 Refunds will not be issued if:
 - Cancellations or changes are requested in writing 48 hours or less prior to reservation date.
 - Permit holder does not arrive by 10:00 a.m. on the reservation date.

There are no refunds for inclement weather.

Applications for use by youth groups must be signed by an adult.

Reservation permit holders must arrive at the reservation site on the date reserved by 8:00 a.m., and place reservation sign at the site. Applicant must have a copy of the approved picnic application with them at the park. The site will be opened to the public for general use at 10:00 a.m. if the reservation holder is not present. An adult representative from the group must be present at all times.

Note: Reservation Holder responsible for placement of Permit Sign at the picnic site by 8:00 a.m. the day of the reservation.
