Emma Prusch Park Barn Use Agreement Addendum (September 2021 - September 2022)

Groups and individuals that are utilizing any rented facility or space must comply with all City of San Jose "City" and County of Santa Clara Public Health orders and guidelines related to the Novel Coronavirus Disease 2019 (COVID-19). The reserving group or individual is required to implement any applicable protocols/guidelines as described in the most current Order of the Health Officer of the County of Santa Clara and any additional City guidelines. City may request the reserving group/individual to submit protocols for review at any time during the term of this rental.

Check In Procedures:

All rules, regulations, and requirements outlined in the current Prusch Park Barn Use Agreement apply. In addition, Barn users will need to schedule an appointment with the Barn Manager to conduct a preoccupancy walk through to confirm pen assignment and review procedures and expectations. The animal pens will be rented in "AS IS" condition with no guarantee of additional repairs, so it is important for the Barn User to inspect their assigned pen during the walk through. If you are not satisfied with the condition of your pen, you may ask to be moved to a different pen if available. Payments must be made at the conclusion of the Barn walk through.

Check Out Procedures:

The expiration date for all barn users will be **September 15, 2022**. Removal of ALL animals, equipment, supplies, materials, and completion of the "Barn Check-Out" with the Barn Manager must be completed NO LATER THAN September 15, 2022. Failure to do so may result in loss of future barn privileges as determined by the Barn Manager, Park Facilities Supervisor, or City Staff.

Composting & Pig Waste

Emma Prusch Farm Park is in the process of developing a composting program with cooperation from Veggielution and UC Cooperative Extension program. Waste produced by the 4H barn animals (except pig waste) will be included in the composting program. We hope that the 4H Barn Users will be excited to participate in this unique opportunity for an on-site composting project. As the composting program develops, 4H Barn Users will be required to participate in informational composting classes and expected to follow the guidelines established for sorting and disposing of animal waste and bedding that will be explained to you through the composting classes. Failure to comply may result in immediate termination of agreement, and removal of animals, and forfeiture of future barn privileges as determined by the Barn Manager, Park Facilities Supervisor, or City Staff.

All pig waste must go in the garbage dumpsters. 4H Barn Users can put all pig manure and debris from daily cleaning into an empty trash can and then dump it into the garbage dumpsters daily. Attaching an empty trash can to a dolly with a bungee cord will be the easiest method to move and dump the pig waste. The pig waste needs to be dumped out daily immediately after cleaning the pens, do not leave pig waste sitting in the can. 4H Barn Users must provide their own equipment (i.e. trash can, dolly, bungee cord).

Educational Presentations:

Each 4H Barn User will be required to participate in a minimum of 3 educational presentations per season. A schedule of opportunities will be made available every season for 4H Barn Users to sign up to present about their animal to a class, camp, tour, or during an event.

PLEASE NOTE: The Current Prusch Park Barn Use Agreement and Fee Schedule are in effect but are in the process of being updated. Current fees will remain the same even though the September 15, 2022 expiration date may cause the Length of Agreement term to be shortened for some. You will receive notification once changes are made to the Barn Use Agreement and Fee Schedule.
