EMMA PRUSCH FARM PARK ADDITIONAL RULES AND REGULATIONS

LOCATION: Emma Prusch Farm Park is located at 647 South King Road, San Jose, CA 95116. The park entrance is located on Lido way and King Road, South of the 680-freeway overpass and north of Story Road.

OPERATION HOURS: Open daily from8:30 a.m. to sunset. Closed on Thanksgiving, Christmas, and New Year's holidays.

PARKING: There is no admission or parking fees.

PUBLIC TRANSPORTATION: Local bus routes to Emma Prusch Farm Park are number 12, 22, 25 and 77. The bus stop is located at Story and King roads.

VEHICLE ACCESS: Vehicles must have authorization to access park grounds. After receiving authorization, vehicles have ten minutes to unload and return the vehicle to designed parking area. Any illegal or unauthorized vehicles are subject to citation and may be towed away at owner's expense.

PUBLIC ART GAZEBO RENTAL: (per 2 hours, no pro-rating): A covered metal structure in the shape of a barn and located across the grass area from the park office. It has 20 ft. by 20 ft. cement floor with 2 metal benches. The barn is suitable for small ceremonies. The ceremony site accommodates for 150 people, and for San Jose Residents reserves at \$250 for two hours within designated time slots, for non-residents the reservation fee is \$300. Ceremony times are from 10:00 a.m.- 12:00 p.m., 1:00p.m.-3:00p.m., and 4:00p.m.-6:00p.m.

RESTROOMS: Public restrooms are located on the north side of the Meeting Hall.

GENERAL RULES:

- 1. Amplified sound (including drums, loud radios/instruments) is prohibited.
- 2. Alcohol and any other consumption of intoxicating beverages are not permitted.
- 3. Decoration plans must be approved by park staff prior to rental date.
- 4. Dogs must be on leashes at all times.
- 5. Children MUST be supervises by an adult in all areas of the park.
- 6. Balloons are not permitted.
- 7. An air jumper with City-approved vendor is permitted only at Citrus Grove public site upon approval by Parks Division Office.
- 8. No additional chairs, or tables should be added to picnic sites
- 9. Please do not feed or harass the animals.
- 10. Party/Costume characters are not allowed to collect money on City Property.
- 11. Smoking is not allowed in City of San Jose parks.
- 12. All San Jose Municipal Codes and State Laws apply.

Reservation Permit holders must arrive at the reservation site on the date reserved prior to 10:00am and remain at the site with a copy of the approved picnic application. The site will be opened to the public for general use at 10:00am, if the reservation holder is not present. An adult representative from the group must be present at all times.
