Reservations must be made in person at the Park Office or on-line: sanjoseca.gov at least three (3) days but no more than one (1) year in advance.

Reservations are processed at Leininger Center, 1300 Senter Road in Kelley Park Monday thru Friday from 8:30 a.m. to 4:30 p.m. The Park Office is closed during the last two weeks in December and on most holidays. Check or money order must be made payable to the *City of San José*.

Cash, VISA, MasterCard, and Discover are accepted. *Prices are subject to change*

Reservation permit holders <u>must arrive at the reservation site on day of reservation and post reserved sign & REMAIN at the site</u> <u>with a copy of the approved picnic permit. The site will be opened to the public for general use after 10:00 a.m. if the reservation <u>holder is not present</u>. An adult representative from the group must always be present.</u>

LAKE CUNNINGHAM PARK ADDITIONAL RULES & REGULATIONS

LOCATION: This 200-acre park located near Eastridge Mall is centered around a 50-acre lake and is home to Raging Waters Water Theme Park and Lake Cunningham Action Sports Park.

OPERATING HOURS: Open daily 8:00 a.m. to one-half hour after sunset.

PARKING:

- Daily parking fee is \$6.00 per vehicle; \$2.00 Discount (Senior, Disabled, or Military); and \$18.00 per bus (fees subject to change).
- Holiday parking fee is \$10 per vehicle; \$6.00 Discount (Senior, Disabled, or Military); and \$30.00 per bus (fees subject to change). Easter Day, Mother's Day, Memorial Day, Father's Day, Independence Day, and Labor Day will be considered as Holiday Parking fee.

Parking tends to fill up early during the busy season. We recommend that you car-pool and arrive early to avoid parking problems. For more information on group parking passes, inquire at time of reservation. Re-entry is permitted, but not guaranteed. Entrances are located on Tully Road and White Road.

ACTIVITIES: Lake is currently CLOSED until further notice for activities: No boating, No fishing, and NO

SWIMMING/WADING. Raging Waters Water Theme Park is located inside the park. Raging Waters is open seasonally.

VEHICLE ACCESS: Vehicles are not allowed on service roads, unauthorized areas, paths or in the picnic areas. However, Rangers may escort vehicles for unloading supplies if time permits. Escort service, is a courtesy, and may be provided for elderly or handicapped visitors. Vehicles parked in unauthorized areas are subject to citation.

RESTROOMS: Located near the reservable group areas except Meadows End.

TELEPHONES: Located at Parking Lot C restroom, and some are located at front entrance of Raging Water.

MARINA: Located adjacent to Raging Waters.

PHOTO PERMITS: Photo permits are required for all commercial photo shoots. This includes professional wedding photographers. Permits can be obtained at Leininger Center, 1300 Senter Road, San Jose, CA 95112.

- ✓ All San José Municipal Codes and State laws apply Alcohol (including beer, wine, & champagne.)
- ✓ Amplified sound only at Cypress Pavilion with approved reservation
- ✓ Dogs on leash and always supervised (no other
- ✓ Only coals in BBQ pits (please no wood, it damages BBQ pits
- ✓ All decorations must be removed and disposed of properly. (tape, string, ribbon, streamers, etc.) Picnic areas must be left clean.
- ✓ Special activities or placing of large equipment must be approved in advance by Park Rangers and Reservation Staff.
- One (1) Air jumper from a City approved vendor is permitted with approved picnic site reservation. An air jump permit is required upon approval by Parks Division office. Please inquire with Parks Division Office for Air Jump Guidelines, vendors, and Permit application.
- ✓ Only One (1) 10x10 shade canopy per reservation
- ✓ Skateboarding, roller skating, or incline skating only on paved sidewalks and pathways (Please visit Action Sports Park)
- √ Vendors hired (party/costume characters, face) painters, catering) must be paid offsite
- Picnic reservation requests for use by youth groups must be signed and accompanied by an adult.

NOT ALLOWED



- Additional tables and chairs from outside of the park
- Amplified sound (including drums, loudspeakers/radios/instruments) with the exception of an approved reservation at Cypress Pavilion
- Dunk tanks
- Truck Vendors (food, gaming, ice cream, etc.)
- Animals (petting zoos, reptile shows, ponies, etc.)
- Generators are not allowed at any City parks for electrical use. Only exceptions are for air jumpers at allowed parks with City approved permit
- It is unlawful to damage, deface, vandalize, or otherwise alter City park property.
- No tape of any kind allowed for covered structures: Cypress Pavilion, Ruby Creek & Cascade
- X Events loitering in parking lots
- Helium Balloons (FAA Regulations) ×
- × Kite flying, motorized scooters, drones, model planes, boats, or remote-control vehicles
- Littering or unauthorized dumping (including business/residential garbage)
- Smoking is not allowed in City of San José Parks
- × Transfer of money on City of San José property
- Vehicles parked or driven within the park, service roads, or paths
- Weapons (including airsoft/paintball guns) or dangerous instruments
