**CLASS SUMMARY:** Under direction, performs work of moderate difficulty relative to the design and installation of landscaping for major city projects. Performs related work as required.

**DISTINGUISHING CHARACTERISTICS:** This is the third level professional class in the Architect/Landscape Architect series. An incumbent of this class is concerned with services dealing with project design, project administration, and supervision of office personnel. Incumbents are supervised by a senior level professional and perform work in the specialized field under the direction of that class. This classification differs from the Associate Structure/Landscape Designer classification in that this is a terminal classification used for current employees who possess a Certificate of Registration issued by the State of California, whereas the former classification does not require a Certificate of Registration. Additionally, new hires may not be hired into this classification.

# QUALIFICATIONS

Graduation from an accredited college or university with a Bachelor's Degree in Architecture or Landscape Architecture, plus three (3) years experience at the level of Structure/Landscape designer with the City of San José. Registration testing may be substituted for the degree requirement. Proof of acceptance must be provided at the time of application.

# **Licensing Requirements**

Possession of a valid Certificate of Registration issued by the State of California. Possession of a valid California driver's license.

# Minimum Knowledge, Skills and Abilities (position requirements at entry and depending on area of assignment):

- Knowledge of current principles and practices as they relate to design, site development and maintenance.
- Knowledge of the types and uses of materials in design and construction.
- Knowledge of grading, drainage, pedestrian and vehicular circulation and parking, recreation facilities, planting, irrigation and lighting.
- Knowledge of building groupings and other structures.
- Ability to prepare master and detailed plans, profiles, sketches and color renderings.
- Ability to perform research and prepare technical reports.
- Ability to prepare specifications and cost estimates.
