CLASS SUMMARY:

Performs a variety of activities to support Airport Operations programs in any of the following areas: the Ground Transportation (GT) Program, Parking Facilities Operations, Shuttle Bus Operations or roadway access control. Works under close supervision to record, monitor and enforce the requirements of the contracts and permits in the Airport Operations areas listed above, and provides customer service to the public.

Distinguishing Characteristics:

The Airport Operations Specialist is the first level of a five-level airport operations series. The Airport Operations Specialist is distinguished from the Senior Airport Operations Specialist by the Senior's level of technical expertise, responsibility to perform lead duties and/or work with limited supervision to provide support to management in administration of day-to-day programs including GT, Airfield Operations, General Aviation, Security Compliance, Airport Communications Center (ACC), construction coordination and Parking/Shuttle. Senior Airport Operations Specialists perform more administrative duties related to contract compliance (such as contracts for parking and shuttle bus operations) versus monitoring the programs. Works under close supervision, interfacing directly with GT operators and contractors.

Incumbents may be required to work weekends, holidays, and any of three shifts.

QUALIFICATIONS:

(These qualifications are typically required. An equivalent combination of education, experience, knowledge, skills, and abilities sufficient to satisfactorily perform the duties of the job may be substituted. Experience for this classification typically substitutes for education on a year-for-year basis.)

Education and Experience:

Two years of college, plus one year of experience in a customer service position.

Licensing Requirements:

- Incumbents are required to pass a background check.
- CPR, First Aid and Automatic External Defibrillator certification within 6 months of employment.
