SUBJECT: ANNUAL AUTOMATIC IN-LIEU FEE ADJUSTMENT

Ordinance No. 28596, Section 15.26.130, Part B, requires the base undergrounding utility fee to be adjusted annually by the Engineering News-Record Construction Cost Index, or its equivalent, effective on January 31 of every year.

The current Engineering News Records (ENR), City Cost Index-San Francisco, Construction Cost Index (CCI) percent change for 2015 is +2.2%. Therefore, we recommend the 2016 In-Lieu Fee for undergrounding utility to be adjusted by +2.2% from \$441 to \$451 per linear foot frontage.

The revised fee will be included in the Report on the Rule 20A and Rule 20B (In-Lieu Fee) Undergrounding Utility Program and the Five-Year Workplan in Spring 2016.
