V. Reports

A. Vice-Chair - Tamiko Rast

Introduced Jessica Shaefer, new PAAC member. She shared highlights of her work managing Facebook's Artists in Residence program and several projects of particular impact including Sites Unseen, a public art project in San Francisco that activates alleyways in the downtown Yerba Buena district with dynamic installations and events.

B. Public Art Director – Michael Ogilvie Reported on:

- 1. Viva Calle event: 50,000 attended, 200 came by the table featuring the Sam Rodriguez mural design at Edenvale Branch Library; feedback was very positive. Mural will begin in April, after the rains.
- 2. Paul Moore Park mural dedication event was held. Councilmember Rocha attended and helped artist complete a final touch on the mural with artist. Project very well-received by community.
- 3. San Pedro Garage Illumination Project community meeting was held, with 30 in attendance, providing much input. Attendees included San José State University students, with emphasis on technology.

1. ACTION: Approved the Design Development Proposal for Artistic Enhancement by artist Mark Reigelman for aesthetic strategies contributing to the St. James Park landscape design by CMG Architects. (District 3)

- 2. ACTION: Approved as amended:
 - 1) The design by the Cat Sparks Art group for a mosaic and mural project at the Washington Youth Center as part of a project by the Washington neighborhoods' Collaborative Community Projects organization. (District 3 Not a SJPA project) *Mvd/2nd: R. James/S. Garg; Passed: 3 Yes (S. Garg, R. James, T. Rast); 0 No; 0 Abstention*
 - 2) Amendment: The PAC strongly recommends that the project team get an artist to paint the mural background rather than leave it up to the contractor who is installing the mosaic elements

There was considerable discussion about how an artist-painted background would significantly enhance the appearance of the mosiac installation, with possible inclusion of some painted butterflies similar to the mosaic butterflies. Artists Juan Carlos Araujo, Lila Gemellos and others present expressed interest in seeing this happen.

Introduced by Michael Ogilvie, Public Art Director; presented by Felice Lopiccolo of Collaborative Community Projects with input from Jeremy Shoffner.

3. ACTION: approved the design for a mural at Hamann Park by artist Lila Gemellos (District 1 - Not a SJPA project).

It was noted that the design presented included a version that is what can be accomplished with the basic funding that is presently in place, and a more enhanced version that can be accomplished if additional funds (approximately \$2,000) are raised.
