

## REPORT: UPDATES ON CONTINUING PUBLIC ART PROJECTS

### Airport Art

Staff is advancing the Amended Airport Art Activation Plan work plan. The repair of the eCloud kiosk glass face is ongoing.

### BART - Berryessa Station (via VTA)

Granite cladding and final bronze artwork element installation scheduled to occur later in the Spring (date to be determined); station is expected to open late 2019.

### Coleman and Basset Underpass Illumination Project

Vicki Scuri and SWA Landscape architects, in collaboration with City's PRNS, conducted a community visioning meeting in November and presented conceptual designs to the community for input on January 29, 2019 in advance of February 5 PAC meeting.

### Convention Center Artwork

A review panel comprised of stakeholders has been formed to help select a muralist from the pre-qualified artist roster to create a mural in an identified inactive wall on the Convention Center. Panel to meet February 1, 2019.

### Edenvale Library – Mural Project for Viva Calle

The artist is scheduled to begin painting the mural in April 2019.

### Environmental Services Department (ESD) Projects:

1. *FOGwaste (Fats Oils and Grease waste)* A video documentation of the fleet is complete and will be promoted.
2. *CoGeneration*: Construction Documents under review. Contract amendment scheduled for Council on February 12, 2019.
3. *Don Edwards National Wildlife Refuge and Guadalupe River/CDM* (two projects): The DENWR project is under construction and will be complete by February 2019; the CDM/Guadalupe River project, is underway with an expected completion by late Summer 2019.
4. *Alviso Storm Pump*: Fabrication in process. Project completion is expected in Summer 2019.
5. *Litterature*: Winning poets contacted. Final designs being prepared.

### End of Watch Police Memorial

The process of contracting a landscape architect is underway as a key step in securing additional support for the project and moving it towards implementation.

### Havana Drive/Midfield Avenue Soundwall mural

Mural design is fully-approved, but creation of the mural is waiting on CalTrans final permit approval in order to proceed; this includes CalTrans requirement for amendments to language in the City's agreement with the artist. Project is expected to proceed in Spring (May) 2019.

### JapanTown Turnkey Park/Plaza Art

City Council has approved the project going forward, with a \$275,000 budget that is being provided by the developer. Staff to begin working with project team early spring 2019. Site groundbreaking for construction is January 31, 2019.

### Neighborhood Galleries

Murals in district 5 will begin in Spring 2019. The second phase of this project is to develop underpass murals in districts 2, 4, 6, and 8.

### Parking Garage Art

Artist Brian Brush's concept design has been put on hold as Public Works is evaluating tile cracking on the Southwest stairwell to determine if the cracking is superficial or structural. In either case, existing tile would need to be removed, which could potentially expand the scope of his design and project.

### Playa to Paseo

Two new installations from artist Laura Kimpton with Jeff Schomberg, XO and HaHa, are installed at City Hall and in Hammer Theatre Plaza from October 21 through March 1, 2019. On February 14, Valentine's Day, the public can have their picture taken in front of XO by professional photographer Dave Lepori from 11:00 am to 1:00 pm and from 5:00 pm to 7:30 pm.

### Pellier Park

Artist Norie Sato and SWA landscape architects are evaluating feedback from December 13th community meeting to incorporate into final design direction.

Sonic Runway

The contract for the Design Phase of a long-term installation of Sonic Runway has been signed with the artists Rob Jensen and Warren Trevezant. Initial research and planning meetings are underway along with fundraising for the Installation Phase.

St. James Park

Artist Mark Reigelman's Design Development proposal was approved by the Public Art Committee on October 2, 2018. In the coming months he will consult with the landscape architects on the paving design.

TJ Martin and Fontana Park murals – 12 MURALS

Murals completed and dedication occurred on December 8, 2018.

Valley Medical Center

Artist Christian Moeller's Concept proposal was presented to the VMC Reviewing Bodies on January 23, 2019 and was positively received.
