The following items are scheduled to be approved by the San Jose City Council on November 14, 2006.

- 1. Approval of an agreement with Allana Buick & Bers, Inc., for consulting services for the Environmental Services Building Repair project, from the date of execution until July 31, 2008, in an amount not to exceed \$282,300 for basic services plus \$28,500 for additional services for a total amount not to exceed \$310,800.
- 2. Approval of Contract Change Order No. 3 with Anderson Pacific Engineering Construction, Inc. for the construction project entitled, "San Jose/Santa Clara Water Pollution Control Plant, FY 2003-2004 Capital Improvement Program, Filter Influent and Effluent Flow Meter Replacement Project," to increase the construction contingency amount by \$13,550 from \$46,700 to \$60,250 fro a total contract amounty not to exceed \$527,250.

- 4. Report on bids and award the purchase of four (4) Variable Frequency Drives (VFDs) to Buckles Smith Electric (San Jose, CA), the lowest responsive bidder, in an amount not to exceed \$706,493.62.
