- 1. Approval of the Fifth Amendment to the construction service agreement with City of Santa Clara for the South Bay Water Recycling Program, revising the approved project list and extending the term of agreement by two years to June 30, 2010, at no additional cost to the City.
- 2. Report on bids and award of construction contract for the project RAS & SS Valve Replacement Project Secondary Tunnel Batter A (A-1 Thru A-6) to the low bidder, Anderson Pacific Engineering Construction, Inc., in the amount of \$729,000, and approval of a contingency in the amount of \$73,000

- e. Metcalf & Eddy in an amount not to exceed \$1 million.

D. <u>Informational Item – TPAC Item Previously Recommended for Approval</u>

The following items were approved by the San José City Council on January 15, 2008:

- 1. Report on bids and award of construction contract for Fire Main Replacement Project Phase I to the low bidder, D&D Pipelines Inc., in the amount of \$292,550, and approval of a contingency in the amount of \$30,000.
- 2. Approval of the first amendment to the agreement with Allana Buick & Bers, Inc. for professional services related to the repair and modifications of the San José/Santa Clara Water Pollution Control Plant's Environmental Services Building, modifying the scope of services and increasing the compensation by \$276,695 for a total maximum amount not to exceed \$587,495; and extending the term of the agreement by twenty-four months from July 31, 2008 to July 31, 2010.
