Negotiate and execute the Fifth Amendment (Amendment) to the Environmental Enforcement Data Management System (EEDMS) Agreement with enfoTech & Consulting, Inc. to extend the term of the agreement by eighteen months from July 31, 2010 to January 31, 2012 and increase the compensation by \$318,199 revised not to exceed amount of \$1,381,598 in order to existing EEDMS to a web based system and to add additional features and functionality.

- b. Exercise five additional one-year options to extend the Agreement for ongoing software maintenance and support at a fixed cost of \$49,500 per year subject to the appropriation of funds.
- c. Execute change orders not-to-exceed a contingency amount of \$72,750 to cover any unanticipated changes to the system upgrade and maintenance and support.

CONSULTANT AGREEMENT FOR WATER POLLUTION CONTROL PLANT MASTER PLAN ENVIRONMENTAL DOCUMENTATION SERVICES WITH ENVIRONMENTAL SCIENCE ASSOCIATES AND **JONES & STOKES (ESA+J&S)**

RECOMMENDATION

Approval of the consultant agreement with Environmental Science Associates and Jones & Stokes Associates, Inc. for the first phase of environmental documentation services (draft project description, review of environmental studies, existing conditions report and draft Notice of Preparation) related to the San José/Santa Clara Water Pollution Control Plant Master Plan for a term commencing upon approval of the agreement through June 30, 2011 and an amount not to exceed \$600,000; with an option for the City to add services at fixed hourly rates, and increase the maximum amount of compensation up to \$2,000,000 and extend the term of the agreement when Council selects the preferred alternative for environmental clearance under the California Environmental Quality Act and pursue preparation of environmental compliance documents under the National Environmental Policy Act.

OUTCOME

Approval of the Environmental Science Associates and Jones & Stokes Associates, Inc (ESA+J&S) agreement will allow securing the environmental documentation necessary to present the San José/Santa Clara Water Pollution Control Plant (Plant) Master Plan to the San José and Santa Clara Councils for approval. The recommended agreement will provide for the completion of the first phase (project description, environmental studies, and Notice of Preparation) of the requirements and documentation mandated by California Environmental Quality Act (CEQA). The agreement will also provide the City with an option to be exercised at fixed hourly rates, to amend the agreement to complete the CEQA documentation for the Master Plan once Council has selected the preferred alternative and to have the consultants prepare National Environmental Policy Act (NEPA) documentation if approved by Council.

BACKGROUND

On November 20, 2007, the Council awarded an agreement to Carollo Engineers to develop a Master Plan for the Plant. This has entailed a three-year planning process scheduled for completion by spring 2011. Once developed, the Plan will involve a 30-year implementation horizon. The Plant Master Plan addresses both the technical wastewater operations of the Plant and the land uses of the 2,600 acres of Plant lands. The Plan also includes a major outreach component to identify and incorporate the community and stakeholder comments.

The Plant Master Plan has released three land use alternatives for public comment (see www.rebuildtheplant.org for details). Over the next few months, staff will be analyzing comments collected at the five community workshops in May and survey results from the website while working with the Community Advisory Group (CAG), stakeholders, and regulators, to develop a staff recommended alternative. A recommendation for a preferred alternative will be presented to the San José and Santa Clara Councils for comment in early 2011. Staff will solicit further comments and feedback from the community in spring 2011 and return to the San José and Santa Clara Councils in late spring of 2011 with a request to move forward on the environmental analysis of a recommended preferred alternative. Certification of the environmental documents and final approval of the Plan are anticipated to be completed by early 2013.

The completion of a program-level Environmental Impact Report (EIR) is required by the CEQA to consider implementing whole or part of the actions recommended in the Plant Master Plan. An Environmental Impact Statement (EIS) or Environmental Assessment (EA) may be required to comply with the NEPA if funds or partnerships for actions in the Plant Master Plan will utilize federal funding. The NEPA strategy will be developed over the next few months, but subsequent NEPA actions will be part of a later phase.

ANALYSIS

On May 3, 2010, the City began a qualifications based selection process and issued a request for qualifications (RFQ# 091007 ESD) for environmental documentation services associated with CEQA and NEPA. The Request for Qualification (RFQ) was advertised on the City's Bidsync and Environmental Services Department (ESD) webpage. Two statements of qualifications were received by the City: one by ESA+J&S, and the other by David J. Powers & Associates (DJPA).

The selections were based on the proposing firm and project manager's experience with major CEQA/NEPA wastewater and land use projects, the overall project approach, corporate sustainability efforts, and Local/Small Business Enterprise status (LBE/SBE). Both proposals qualified for the LBE preference and DJPA qualified for SBE. A five-person team made up of members from San Jose's ESD, San Jose's Planning Building and Code Enforcement (PBCE) Department, and City of Santa Clara Planning Division, scored the above criteria on a 100 point scale.

ESA+J&S provided superior project management experience, a greater understanding and specific work related to large wastewater treatment plants and master planning, and a clearer project approach. The ESA+J&S team also has extensive experience with local projects related to land use and environmental impacts, which include: preparation of the Santa Clara Valley Habitat Plan by Jones and Stokes, land use development plans completed by HMH, traffic and circulation analysis by Fehr & Peers, hazard analysis by Arcadis, water quality regulatory expertise from EOA, and hydrology, sea-level rise, and flood management analysis from Philip Williams & Associates.

The ESA+J&S team has completed similar environmental documentation projects for the Sacramento Regional County Sanitation District Master Plan and the San Francisco Public Utilities Commission Sewer System Master Plan. The team has also completed major environmental work for the East Bay Municipal Utility District and the Santa Clara Valley Habitat Plan. References on similar projects also gave positive marks to the consultant team and the project manager.

The environmental documentation included in this contract, to be completed prior to the summer of 2011, will focus on documenting existing conditions, identifying a federal NEPA responsible agency, and providing preliminary input to the Plant Master Plan consultant team on potential CEQA and NEPA issues pertaining to the land use alternatives. Staff has negotiated this scope of work for a not to exceed amount of \$600,000, and believe it is appropriate for the level of effort required to complete this phase. Final certification of the Plan as part of the contract option, however, requires a significantly larger effort which would involve, finalizing a CEQA compliant project description and Notice of Preparation, completing required technical studies, preparing a Draft EIR, responding to Draft EIR comments, and preparing a Final EIR. In addition, if the City elects, the consultants will also prepare NEPA documentation with this contract option. This work described in the contract option will commence after the Council approval of the preferred alternative, which is anticipated to be in spring 2011. Hence, staff is recommending the inclusion of an option to extend the contract beyond spring 2011 and increase the total contract amount to not to exceed \$2,000,000. The recommendation to Council on the preferred alternative will include the final negotiated not to exceed amount for the option and identification of the funds necessary to exercise the option.

POLICY ALTERNATIVES

Alternative #1: Direct staff to complete the environmental documentation

Pros: May reduce overall contract costs

Cons: Limited City resources to complete the complex set of tasks. General lack of experience in handling large wastewater facilities environmental documentation.

Reason for not recommending: The complexity of the environmental documentation for the Plant Master Plan would likely include the use of many outside specialists. Individual contracting for the many specialists would yield a challenge for the contract manager, likely would result in less efficiency than a single contract manager with expertise in this area and a delay of this critical project.

This memorandum and scope of services for this contract has been coordinated with the City Manager's Budget Office, the City Attorney's Office, and PBCE. This item is scheduled to be heard by the Treatment Plant Advisory Committee (TPAC) on September 9, 2010.

EVALUATION AND FOLLOW-UP

Staff will continue to provide verbal updates to the Transportation and Environment Committee until the Plant Master Plan is completed and approved by the San José and Santa Clara Councils. Updates on the environmental documentation scope of work will be a key component of these updates beginning early 2011. After the initial environmental documentation is complete, exercise of the option will be brought to Council.

FISCAL/POLICY ALIGNMENT

This Council item is consistent with Council approved Budget Strategy Memo General Principle #2, "We must focus on protecting our vital core City services." The Plant Master Plan is also in

RECOMMENDATION

Appoint San Jose City Councilmembers Kanson Chu and Peirluigi Oliverio and City of Santa Clara Mayor Patricia Mahan to serve on the joint Recycled Water Policy Advisory Committee established in the recent Recycled Water Facilities and Program Integration Agreement between the City of San Jose and the Santa Clara Valley Water District.

OUTCOME

Approval of this recommendation will allow Councilmembers Chu and Oliverio and Mayor Mahan to serve as the three members of the Policy Advisory Committee representing cities or agencies that are voting members of the Treatment Plant Advisory Committee.

BACKGROUND

In April 2010 the City executed the "Recycled Water Facilities and Program Integration Agreement" with the Santa Clara Valley Water District. The goal of that agreement was for the District and City to financially support the production and use of recycled water in Santa Clara County and to coordinate and cooperate their efforts "to achieve the most cost effective, environmentally beneficial utilization of recycled water to meet both water supply and wastewater treatment and disposal needs." RECOMMENDATION

Report on bids and award of contract for the SJ-25 Recycled Water San Jose School Extensions – Phase B project to the low bidder, Northern Underground Construction, Inc., in the amount of \$301,322 and approval of a budget contingency of 15% of the contract amount (\$45,198).

OUTCOME

Approval of this contract will allow construction of a pipeline to expand the recycled water system in accordance with the cooperative agreement between the City of San José and the US Bureau of Reclamation (Bureau). Approval of a 15% contingency will provide funding for any unanticipated work necessary for the completion of the project.

BACKGROUND

In March 2009, the Bureau announced a grant program funded by the American Recovery and Reinvestment Act of 2009 (ARRA). The City of San José submitted an application to the Bureau identifying several recycled water projects which would qualify for federal funding under the program. In April 2010, the City Council adopted a resolution authorizing the City Manager to execute an agreement with the Bureau to accept \$6.46 million in ARRA grant funding towards the design and construction of \$14.8 million in South Bay Water Recycling pipeline extensions and related facilities. The SJ-25 Recycled Water San Jose Schools Extension project is one of eight projects defined in the agreement. A cooperative agreement between the City and the Bureau was subsequently executed on April 30, 2010.

This project involves the construction of approximately 2,820 feet of 6-inch and 4-inch recycled waterlines. This recycled waterline will increase the amount of recycled water usage, enhance future reliability expansions of the system, and minimize capital cost. One extension, consisting of 1,890 feet of pipeline, will be installed in McLaughlin Avenue and Lightland Road. A second extension, consisting of 930 feet of pipeline, will be constructed in Classico Avenue, Bianco Way, and Magnum Drive. Work is scheduled from October 2010 to January 2011. Some prospective users and customers include City parks, a church, County of Santa Clara facilities, and local schools. Prospective customers will need to complete a permitting process in order to be able to connect to the recycled water system.

Pursuant to the cooperative agreement between the City and the Bureau, this project qualifies for funding reimbursement for 44% (\$179,080) of the total project cost (\$407,000), which includes the recommended construction contract, project delivery, and contingency.

The bid documents submitted by the low bidder, Northern Underground Construction, Inc. were evaluated and found to be in order. The low bid submitted by Northern Underground Construction, Inc. in the amount of \$301,322 is 25% below the Engineer's Estimate. The median and average bid amounts are 14 percent and 13 percent above than the Engineer's Estimate, respectively. Considering the current steep competition in the construction industry in the Bay Area, staff considers the bid proposal submitted by Northern Underground Construction, Inc. reasonable for the work involved.
