## REGULAR MEETING MINUTES FEBRUARY 8, 2018

#### 1. CALL TO ORDER & ORDERS OF THE DAY

#### CALL TO ORDER

Chair Parker convened the Appeals Hearing Board at 6:31 p.m. in the City Council Chambers of City Hall, 200 E. Santa Clara Street, San Jose, CA 95113.

# a. 8 SOUTH 1<sup>ST</sup> STREET (467-62-017) APPEAL SUSPENSION OF ENTERTAINMENT PERMIT

Vice Chair Cabanayan recused himself due to conflict of interest and left the room. Vice Chair Cabanayan disclosed to the Secretary for the Board that he leases office space in the same building that is the subject of the enforcement action on appeal before the Board.

#### Action:

Lieutenant Todd Trayer of the San Jose Police Department presented information in support of suspending the Public Entertainment Permit on the grounds that (1) Studio 8 used promoter services from Mr. Embay, an individual that did not have a license or an indemnification contract from Studio 8; and (2) nuisance arising from security conditions following the closing of Studio 8 doors due to overbooking and Mr. Embay shooting at or above the crowd about an hour thereafter. Kendra McGee-Davies, Senior Deputy City Attorney for the City of San Jose, noted Mr. Embay engaged in promoter activities in violation of the Code, and was otherwise compensated for these services from the compensation for booking tables and a cut of the entertainer contract. Moreover, Mr. Embay's actions to promote the event, his presence at Studio 8, and the efforts to address the overbooking gave rise to security issues on the night of the event.

Diamond SJ Enterprise dba Studio 8 owner Jenny Wolfes, was represented by legal counsel, Gill Sperlein. Mr. Sperlein presented information to rebut the basis for suspension:(1) Mr. Embay was retained because he had the contract with the entertainer and was only paid for the contract; (2) Ms. Wolfes did not agree Mr. Embay could separately book tables and receive the revenues from the bookings as compensation for his services; (3) any security issues from closing the door early were quickly addressed; and (4) Ms. Wolfes should not be responsible for the security issues arising out of the shooting because it occurred after Ms. Wolfes had ended her relationship with Mr. Embay.

The Board members closed public hearing, and discussed the different information presented and how the information either supported or did not support the Administrative Decision. The Board voted on two motions.

There was a motion by Commissioner Kenny, seconded by Commissioner Parsons, to order as follows:

To find the Administrative Hearing Officer's decision, to suspend Diamond SJ Enterprise dba Studio 8's public entertainment permit for 30 days because Studio 8 engaged the services of a promoter in violation of the San Jose Municipal Code Promoter License requirement, was based on substantial evidence.

This motion failed. The Board makes no determination with respect to this portion of the Administrative Decision.

There was a motion by Commissioner Kenny, seconded by Commissioner Parsons, to order as follows:

To find the Administrative Hearing Officer's decision to suspend Diamond SJ Enterprise dba Studio 8's public entertainment permit for 30 days because of the security issues at or around Studio 8 on or about the night of May 28, 2017, was supported by substantial evidence.
