- Courtesy graffiti abatement services on private property to remove offensive/gang related graffiti
- Free paint to remove graffiti

## ANTI-LITTER PROGRAM

The Anti-Litter Program allows your group to take stewardship of a desired area in your neighborhood by; including areas around schools, businesses, parks, sidewalks, storm drains, gutters and trails.

### YOUR REQUIREMENTS TO ADOPT AN AREA

- Commit to one year and volunteer a minimum of six times per year (on your own or in a group)
- Report volunteer hours and total number of bags of litter collected each month

### TIPS TO PROTECT YOUR PROPERTY

- Plant fast growing vines or spikey vegetation, like bougainvillea, along fences and walls, plant trees near a graffiti plagued wall. This will help prevent access.
- Install lighting in areas that are dark and often hit with graffiti.
- Use anti-graffiti coating in high-risk areas as this makes for easy removal.
- Maintain your property. Poorly maintained properties attract graffiti.
- Get educated! Learn about graffiti, and how it impacts your community.

### SAN JOSÉ MUNICIPAL CODE SECTION 9.57.300:

"No person shall maintain graffiti that has been placed upon, or allow graffiti to remain on, any real property, including but not limited to any building or structure, nor on any motor vehicle, boat, trailer, or other personal property located on the real property, when the graffiti is visible from a street or from any other public or private property."
