# Meeting Minutes August 20, 2018

#### I. Call to Order & Orders of the Day

Action: Upon a motion by Commissioner Dawson, seconded by Brown, the recommendation the Arts Commission to review and accept the Arts Commission's annual report for FY 2017-2018 and workplan for FY 2018-2019 and recommend its approval by the City Council's Community and Economic Development as required by City Council was approved. (11-0-0)
