### CHAIR (Candidate 1)

## Ron P. Muriera

Position: Chair, San Jose Arts Commission

My fellow San Jose Arts Commissioners: As I approach my 7th year of serving on the Arts Commission, it would be my privilege and honor to serve as your Chair for the 2019-20 term. For those colleagues who are not familiar with my service on the Arts Commission:

- I am currently serving as the Vice Chair of the Arts Commission for the 2018-19 term;
- Presently in my 4th year serving on the SJ Arts Commission Executive Committee, currently holding the position of Chair;
- I served for 2 years as Chair of the Public Art Committee (PAC). During my time as PAC Chair, I have taken the lead on several policy and legislative issues related to Public Art funding in the City of San José, as well attending the launch/celebration of events focused on public art in San José;
- I served 2 years as a member of the PAC;
- Served as Chair for OCA Grants Appeal Review Committee (2016-17); Served on Cornerstone for the Arts Selection Committee;

- For the last 3 years, I have represented the Arts Commission on the San Jose Creates and Connects Advisory Committee;
- For the last 5 years, I have served on grant review panels for Office of Cultural Affairs (OCA) grant programs (take pART; Festival, Parades & Celebrations);
- Participated at City of San Jose Resource Fair, staffing Arts Commission Table with Commissioner Ramona Snyder, and the District 2 Resource Fair, staffing Arts Commission Table with Chair Richard James;
- Represented the Arts Commission serving on the Santa Clara County Office of Education's Artspiration Strategic Plan Committee (2017-18);
- Invited to speak with SoFA artists and arts/cultural organization representatives at an informational convening at Café Stritch, along with Commissioner Tina Morrill and former Arts Commissioner Peter Allen; and
- Represented the SJ Arts Commission at Americans for the Arts Convention in San Francisco (2017) and California Arts Convergence convening (2015).

In addition to my service on the SJ Arts Commission, I currently serve on the boards of two state arts organizations: California Arts Advocates (501c4), and its sister 501c3 affiliate Californians for the Arts, where I serve as Vice President of both boards, Chair the Fund Development Committee, and serve on the Advocacy Committee. I am presently the Development Director for San Jose Stage Company, and consultant to various arts and cultural institutions in San José and the greater SF Bay Area. As you can see, I am very passionate about representing and advocating for arts and culture in San Jose, our region, and throughout California. Lynne has served on Executive and Public Art Committees. Her community engagement background in various San Jose neighborhoods combined with her academic credentials make her an ideal candidate to lead the San Jose Arts Commission in its advisory role to San Jose City Council.

Lynne possesses critical thinking skills. Ever since she has been on the Arts Commission she has spoken earnestly of the opportunity and need to have art distributed throughout San Jose so that the arts can impact our whole community and the visitors who come here. Her active participation in Commission conversations demonstrate her continued awareness of and commitment to San Jose's cultural vitality. Lynne is a non-profit consultant utilizing twenty-five years of experience in software and semi-conductor companies to assist non-profits with program evaluation, outcome research and fundraising. Selected volunteer activities include: Board of Directors, Fairground Heritage Foundation of Santa Clara, Franklin McKinley Children's Initiative Governance Committee, San Jose Arts Commission, Grant Evaluator, The 100 Women Foundation, and Secretary Elect, Los Gatos Morning Rotary; past Trustee and continuing volunteer for the San Jose Museum of Art; and past founding Director of Community Outreach, Silicon Valley Business Travel Association. Recipient of District 7 Certificate of Appreciation for Community Involvement and Service to the Santee Neighborhood, Lynne plays a key role in the ongoing revitalization of the Santee Community in South San Jose. She also serves as

an occasional advisor to several Silicon Valley start-up social enterprises. In addition, she is the Associate Director for Evaluation and Outreach of the Sunday Friends Foundation.

Lynne holds a BS and MS in Experimental Psychology and a PhD in Applied Statistics from Purdue University, West Lafayette, Indiana. She and her husband, a Senior Scientist at NASA Ames, are long-time residents of Almaden Valley. (See next page.)
