#### **RECOMMENDATION**

Forward a recommendation to the Arts Commission to review and accept the revised nomination guidelines for the Cornerstone of the Arts awards.

#### **BACKGROUND**

Inaugurated in September 2013, through a partnership between the City of San Jose Office of Cultural Affairs and the Arts Commission, the Cornerstone of the Arts awards and event program was established.

The awards have been bestowed annually at the Cornerstone of the Arts Event, during which Cultural Affairs grantees are also honored for their collective contributions. In 2016, the program was expanded in two important ways. Community members may now submit nominations, and the awards have expanded to include two new categories, Business Support for the Arts Award and Creative Impact Award.

- **Cornerstone of the Arts** To award an individual or individuals who have provided enduring and effective leadership and/or support that has led to the betterment of the San Jose's arts community and thus improved the quality of life for our citizens.
- Creative Impact Award To award an individual or individuals who (nonprofit, business sector, or individual) have led a cultural or artistic project or special event that has made a significant impact on the community.
- Business Support for the Arts Award To award a business that has demonstrated a strong support of the nonprofit arts sector in San Jose.

# **ANALYSIS**

Based on the five years of success of the Cornerstone of the Arts program along with feedback and observations, the Office of Cultural Affairs staff recommends revising the nomination guidelines allowing San José City staff to nominate candidates to each award category. From the previous years of expanding the nominations to the public, the Office of Cultural Affairs only received a few nominations for each of the award categories. In 2017, only eight nominations were received for the Cornerstone of the Arts Award, two nominations were received for the Creative Impact Award, and three nominations were received for Business Support for the Arts Awards. Because of the small number of nominations, the deadline was extended to allow for additional nominations. All nominations will be considered by the evaluation panel and forwarded to the Arts Commission for approval.

In addition, the Office of Cultural Affairs recommends on revising the descriptions of the Cornerstone of the Arts and Creative Impact awards to be more explicit that creative entrepreneurs are eligible for the Cornerstone of the Arts and Creative Impact awards. Since the beginning to the program, the Office of Cultural Affairs has had the same comments from the public and Commission to include an additional award category for artists. Details of the revisions to the guidelines are in the attached memo.

With the revisions to the guidelines of the program, it is the intention of the Office of Cultural Affairs and Arts Commission to work jointly to create a successful program and event that promote the arts in San Jose and recognize those that have made a longstanding impact on our cultural landscape.



# NOMINATION GUIDELINES

# DEADLINE: May 11, 2018 by 5:00 p.m.

The San Jose Office of Cultural Affairs and the Arts Commission are pleased to announce this year's nomination process for honoring exemplary art leaders.

Join us in celebrating the value that the arts bring to our community by nominating an inspiring person, organization, or business that has made a cultural impact. Awards will be presented at the annual Cornerstone of the Arts event in October 2018. # **2018 Award Categories**

This year's award categories shine the spotlight on individuals, creative entrepreneur, organizations, and businesses who have made a significant impact in strengthening the vibrancy of San Jose through their leadership and support for the arts.

- Cornerstone of the Arts An individual(s) or creative entrepreneur who have provided effective leadership and/or support over time, leading to the betterment of San Jose's arts community and the quality of life for our citizens.
- Creative Impact Award An individual(s) or creative entrepreneur from either the nonprofit or business sector who have led a cultural or artistic project or special event that has made a significant impact on the community.
- Business Support for the Arts Award Businesses that have made a significant impact in strengthening the vibrancy of San Jose through their leadership and support for the arts. It is envisioned that the selected honoree is a business that support the arts philanthropically or through a sponsorship.

# **Nomination Process**

Nominations are welcome from public, current members of the San Jose Arts Commission, and San José City staff. Self-nominations & current Arts Commissioners are not eligible for nominations.

Applications must include the following:

- > Nomination cover form
- > Nominator's statement

Nominations will be reviewed by a panel comprised of members of the Arts Commission, Office of Cultural Affairs staff, community representatives, and past award winners. The award recommendations of the panel will be submitted for approval by the Arts Commission. For each award, both the nominator and the honoree will be notified. In nonaward cases, only the nominator will be notified.

# **Cornerstone of the Arts Award**

**Description:** An individual(s) or creative entrepreneur who have provided enduring and effective leadership and/or support that has led the betterment of San Jose's arts community and the quality of life for our citizens.

# **Eligibility:**

- An individual or individuals (not an organization)
- Working in any sector (nonprofit, public, or private)
- Past honorees are ineligible.
