I believe that people in other parts of the city dont really realize that the growing number of homeless people are with us either with services or without them. So I believe the more affordable housing and services we can get the better for all of us. If we do not get more housing other parts of the city are going to feel the impact more as the homeless population spreads out. Having lived in an impacted area I have begun to realize how much of the services we home dwellers take for granted do not exist for people that don't have housing. For eample, garbage collection is tied to having an address and utility bill, and . Access to toilets is limited as more and more store now lock their restrooms. This proposed projet would house 147 people who might otherwise be on neighborhood streets as homeless. That is 147 fewer bodies with no resources for their safety and no sanitation resources. I hope these homes will be built and made available to the folks that need them the most.

I am a former president of the Cottle Lean Neighborhood Association for District 2 in the City of San Jose. About a year ago several board members of CLNA joined me on a tour of several long-time established Catholic Charities facilities to see for ourselves first-hand what it is they are proposing for the ACO Furniture site. What we found was that everyone must pass through screening personnel to enter any facility (not weak security), facilities facing main streets and thoroughfairs (not at high risk locations), little crime (according to police reports, less than other areas), and strict tenant vetting as explained to us from a representative giving us the tour. I would also like to mention we have a neighbor who rents a rooms in her house to Catholic Charities clients and this neighbor was impressed with their screening procedure. One tenant gave her a little problem and was immediately removed. Not one local business at these other facilities complained of revenue loss. The representative for CC explained a very clear eviction process for their facilities. Tenants are screened for drug addiction, mental illness, and criminal history.

We think it's some else's responsibility to build housing, to solve the homeless problem, then we get what we've got, which is a region plagued by spiking homelessness and a housing crisis.
