The Commission supports the San Jose Clean Energy (SJCE) draft program guiding principles, which include promoting equity and supporting disadvantaged communities, maximizing greenhouse gas reduction opportunities, aligning with Climate Smart San Jose, and producing customer and community benefits. In addition, the Commission supports promoting energy programs such as vehicle and building electrification, distributed energy resources, and rates. These programs will result in reduced greenhouse gas emissions. Furthermore, the Commission believes that community solar, which is included in the Climate Smart Plan, is a good energy program to include in the roadmap, especially if it is combined with storage. Finally, the Commission will continue to follow the progress of the energy programs roadmap.
