Planned Development Zoning from the Commercial Pedestrian Zoning District to the CP(PD) Planned Development Zoning District; and a Planned Development Permit to allow the development of two sevenstory mixed-use buildings with one level of below-ground parking, including 173 residential units and approximately 17,189 square feet of commercial uses on an approximately 1.34-gross acre site.

Purpose: To describe the proposed project, the environmental review and planning process, and obtain community input on the project and issues to be discussed in the Environmental Impact Report (EIR) analysis.
