The City of San José issues two different types of Residential Parking Permits – Residential Vehicle Permit Stickers ("Stickers"- assigned to specific vehicles) and Visitor Permit Hangers ("Hangers"- transferable between vehicles) Permits are \$35 each, unless otherwise stated. Permit limits vary by zone. Please see the reverse side of this application for permit limits for your zone.

Copies of the following are required for each applicant, unless otherwise noted in 'Applicant Names & Relationships' below.

- A) VALID PHOTO IDENTIFICATION
- **B) PROOF OF RESIDENCY:** One of the following documents reflecting the applicant's name and address.
 - Current lease agreement ^a
 - Tennant verification form
 - Entire current (last 90 days) copy of utility bill
 - Current property tax bill

For Residential Vehicle Permit Sticker(s), the following is also required:

C) CURRENT DMV REGISTRATION: Valid registration copy reflecting owner name, make, model, and permanent license plate number of vehicle. One sticker will be issued for each valid DMV registration submitted, up to the maximum number per residence.

^a Note: Lease Agreements are not accepted as proof of residency in Horace Mann and SUN Zones. Use Tennant Verification Form.

Each adult resident (age 18 and over) must sign this application authorizing the Lead Applicant to obtain permits on their behalf. If requesting Visitor Permit Hanger(s), approved Hanger(s) will be assigned to the Lead Applicant.

RESIDENTIAL PERMIT PARKING POLICIES

1. To apply for permits, mail or bring in this application and copies of all required documents to the address below:

200 East Santa Clara Street, 8th Floor, San Jose, CA 95113

- 2. Permits are issued from 8:00 A.M. to 5:00 P.M., Monday through Friday, except City holidays. Permit applications received after 5:00 P.M. will be processed the following business day. If a field investigation is required, applications may take up to 10 business days to process. Payment is accepted by Visa, American Express, MasterCard, Check or Money Order (Payable to: City of San José), or Cash in the exact amount (Note: The DOT Permit Center does not have the ability to make change.)
- Non-resident property owners may obtain only one (1) guest permit hanger per zone, upon proof of ownership of
 property (current property tax bill) within a designated permit parking area. In addition, non-resident property
 owners must provide proof of residency (see 'proof of residency' requirements) at an address separate from the
 owned property.
- 4. All permits must be prominently and properly displayed to be valid. Parking citations will be issued to any vehicle parking in a permit area without the appropriate permit. The residential parking permit must be applied to the inside bottom left corner of the rear window and be visible to enforcement officers. For vehicles with tinted rear windows or obstructed by a camper shell, the permit must be applied to the inside bottom left corner of the front windshield. Guest permit hangers must be displayed facing outward on the rearview mirror of the vehicle. For motorcycles, the residential permit must be applied to the front left fork.
- 5. If a permit is lost or stolen, there is a non-refundable replacement fee for each permit. The replacement fee will be waived only when a copy of an incident police report and case number are provided to the DOT Permit Center.
- Vehicles displaying residential parking permits are not exempt from complying with parking restrictions such as
 red zones, metered spaces, and other time-restricted zones. Vehicles with valid California handicap placards are
 exempt from residential parking permit restrictions.
- 7. The Director may revoke all permits and/or deny application for issuance or renewals of permits if individuals are found to provide inaccurate information, violate any conditions placed upon the parking permit, and/or fail to comply with any provision of San Jose Municipal Code Chapter 11.48.
