Council Member Rose Herrera seconded the motion.

Mayor Sam Liccardo opened the floor for public testimony.

Mayor Sam Liccardo expressed appreciation to all the comments and suggestions presented by the speakers and the Council Members.

Action: On a call for the question, the motion carried, the Rules and Open Government Committee Report dated December 3, was approved. The memorandum from Mayor Sam Liccardo, dated January 2, 2015, was approved, directing Staff to agendize Item G.6 from the December 3, 2014 Rules Committee Report entitled "Support for Immigration Services" to the January 27, 2015 Council Meeting in order to allow the entire Council to consider the following proposal from Vice Mayor Nguyen, Council Members Liccardo and Khamis, dated November 25, 2014: (a) Direct the City Manager to return to the Neighborhood Services and Education Committee and through the mid-year budget process to Council, to create a plan to address the imminent flood of inquiries from thousands of City of San José residents who might qualify for relief from deportation under President Obama's recent Executive Action and under the Deferred Action for Childhood Arrivals (DACA). (b) Specifically the City Manager should assess the resources required to perform several specific tasks critical to ensuring that otherwise law-abiding undocumented immigrants in San José can fully benefit from the Obama Administration's recent actions. In consultation with key partners, including the Santa Clara County Office of Human Relations, the South Bay Immigration Services Network, SIREN and other nonprofit organizations serving immigrants in the community, the City should assess whether its network of existing nonprofits already addresses the impending need and what, if any, role the City should play in such tasks as: (1) Referring residents to competent legal service organizations and U.S. government offices where they can obtain critical services and additional information. (2) Tracking and making public the identity of those organizations and individuals exploiting vulnerable immigrants seeking legal services and to warn residents against the use of those specific providers. (3) Proactively performing outreach in many immigrant communities to ensure that families can take full advantage of the programs under the Executive Action or DACA. (4) Assessing whether the City is taking full advantage of available grant funding from federal sources or foundations to better serve its immigrant communities through City processes, such as by assistant immigrant-led businesses in navigating City Permit processes or ensuring that adults have access to English as a Second Language (ESL) and literacy programs through City libraries. (c) Any funding needs should be raised and discussed during the Council's mid-year budget process in February 2015. The memorandum from Council Members Kalra, Peralez, Carrasco and Nguyen, dated January 9, 2015, was approved, with the City Manager directed to: (a) Bring back a plan to establish an Office of Immigrant Affairs, as well as a report back on a potential Welcome Ordinance. (b) Investigate and outline a plan for coordination with the County of Santa Clara. (c) Explore and report back to the Council on options of utilizing current City sources. (d) Report back to the Council on the costs and scope of work of designating roles to Parks, Recreation and Neighborhood Services Staff. (10-1. Noes: Oliverio.)

<u>Motion</u>: Council Member Ash Kalra moved approval to direct the City Manager to prepare a letter to be sent on behalf of the City of San José in opposition of the proposed Phillips 66 oil train offloading facility in San Luis Obispo County. Vice Mayor Rose Herrera seconded the motion.

Council Member Johnny Khamis requested to amend the motion to strike the last sentence on the second paragraph of the draft letter from the City Manager "Our current rail system is designed to connect residents to their destinations throughout the entire Bay Area, not to move large quantities of hazardous materials like crude oil". Council Member Ash Kalra respectfully declined to accept the amendment.

Council Member Ash Kalra requested to amend the motion to add to the letter regardless of whether the rail systems are transporting people or goods: "Safety is the City of San José's primary concern" and to direct Staff to continue to identify any opportunities for grant funding from the Federal or State levels in terms of rail safety for local jurisdictions. Vice Mayor Rose Herrera accepted the amendments.

City Attorney Richard Doyle, Interim City Manager Norberto Dueñas and Director of Intergovernmental Relations Betsy Shotwell responded to Council questions and concerns.

<u>Substitute Motion</u>: Council Member Pierluigi Oliverio moved approval to defer this item until January 27, 2015 in order to allow time to receive further information from the Federal delegation. Council Member Johnny Khamis seconded the motion.

Vice Mayor Rose Herrera and Council Member Ash Kalra expressed opposition to the substitute motion citing that the Council has a responsibility to the residents and it was important to move forward without delay.

Mayor Sam Liccardo opened the floor for public testimony.

<u>Public Comments</u>: Expressing comments about public safety issues, support to the recommendations from Council Member Ash Kalra, support for a letter in opposition to the proposed Phillips 66 oil train offloading facility in San Luis Obispo County, support for clean energy and improving safety for oil by train and other comments were: Bastiaan Bergman, Michael Kutilek, Sustainable San José; Simone Cardona, Forest Ethics; Fran Salisbury, Deborah Levoy, Tonya Parnak, John Fioretta, Gerry Hunt, Stephanie Flaniken, Valerie Love and Kelsey Baker, Center for Biological Diversity.

On a call for the question, the substitute motion failed. (2-9. Noes: Carrasco, Herrera, Jones, Kalra, Matthews, Nguyen, Peralez, Rocha; Liccardo.)

The original motion presented by Council Member Ash Kalra and seconded by Vice Mayor Rose Herrera was back on the floor for consideration.

Council Member Johnny Khamis expressed support to the motion only because it is important to send a message regarding the City of San José's concerns for safety and the environment.

Action: On a call for the question, the original motion carried unanimously, Staff was directed to prepare a letter to be sent on behalf of the City of San José in opposition of the proposed Phillips 66 oil train offloading facility in San Luis Obispo County with the following addition from Council Member Ash Kalra concerning regardless of whether the rail systems are transporting people or goods: "Safety is the City of San José's primary concern". Staff was further directed to continue to identify any opportunities for grant funding from the Federal or State levels in terms of rail safety for local jurisdictions. (11-0.)

OPEN FORUM

- (1) Perry Mistry urged the Council to create more jobs in San José.
- (2) Ross Signorino suggested that the Council Members use microphones that light up "red" when speaking at the Council Meetings.
- (3) Brian Darby complained about traffic issues near Santana Row and suggested that Council allow people with disabilities to bring a laptop to the podium to aid in speaking.

ADJOURNMENT

The Council of the City of San José was adjourned at 4:23 p.m. in memory of Irene Dalis, who passed away on December 14, 2014 at the age of 89. Ms. Dalis, San José native and mezzo-soprano, was both an international opera star and the founder of the successful company Opera San José. (Herrera)
