STRATEGIC SUPPORT SERVICES

3.1 Report of the City Manager, Edward Shikada (Verbal Report)

Action: On a call for the question, the motion carried unanimously, and the 2014 Legislative Guiding Principles as edited by the Council Committees, and the Legislative Priorities and Advocacy Issues for the second year of the two-year Legislative Session in Sacramento and the 113th Congress, was accepted, with staff directed to come up with additional guiding principles on the management of medical marijuana collectives, expanding on Section VII, Item 11, "Urge Federal Drug Enforcement, and the Food and Drug Administrations to remove marijuana from Schedule 1 of the Controlled Substances Act of 1970". 3.4 Approve an ordinance:

- (a) Making legislative findings that the online or electronic filing system for the filing of campaign statements will operate securely and effectively and would not unduly burden filers;
- (b) Prescribing that the format for campaign statements filed electronically shall be the standardized filings developed and approved by the Secretary of State, as amended from time to time; and
- (c) Establishing a sixty (60) day grace period to commence from the effective date of this ordinance to allow for information to be disseminated and in order to ensure filers and City staff have sufficient training to transition to paperless filing.

<u>Public Comments</u>: Ross Signorino stressed the importance of safety vests for bicyclists and the need for it to be codified.

City Auditor Sharon Erickson and Staff presented the report and responded to questions from Council. Deputy City Manager Joseph Horwedel responded to questions.

Director of Public Works David Sykes provided an update on the project status, and Assistant Director of Planning, Building and Code Enforcement Laurel Prevetti discussed the environmental process.

City Attorney Richard Doyle clarified California Environmental Quality Act (CEQA) requirements.

<u>Motion</u>: Council Member Oliverio moved approval of the staff's recommendations, with the inclusion of Director of Planning, Building and Code Enforcement Joseph Horwedel's supplemental memorandum of January 10, 2014. Vice Mayor Nguyen seconded the motion.

<u>Public Comment</u>: Bruce Tishinin and Richard Zappelli (Willow Glen Neighborhood Association) offered support to the Staff recommendations. Larry Ames and Scott Lane recommended refurbishing the bridge and placing it on the historical registry. Richard Nieset also offered opposition to its demolition, adding that a full Environmental Impact Report (EIR) should be required.

The Council engaged in a lengthy discussion.

Council Member Campos and Rocha expressed that due to the historical significance of the trestle, they would not be supporting the motion.

Action: On a call for the question, the motion carried, and Resolution No. 76904, entitled: "A Resolution of the Council of the City of San José Adopting the Three Creeks Trail Pedestrian Bridge Project Mitigated Negative Declaration, for which an Initial Study was Prepared, all in Accordance with the California Environmental Quality Act, and Adopting a Related Mitigation Monitoring and Reporting Program"; Resolution No. 76905, entitled: "A Resolution of the Council of the City of San José Authorizing the Director of Public Works to Award the Construction Contract for the Three Creeks Pedestrian Bridge Project to the Lowest Bidder in an Amount Not to Exceed \$1,650,000 and to Execute Change Orders in Excess of \$100,000 Within the Contingency Amount"; and Ordinance No. 29365, entitled: "An Ordinance of the City of San José Amending Ordinance No. 29271 to Appropriate Monies in the Subdivision Park Trust Fund for the Trail: Three Creeks Interim Improvements and Trestle Bridge Project: and Providing that this Ordinance Shall Become Effective Immediately Upon Adoption", were adopted.
