2.7 Adopt a resolution authorizing the City Manager or his designee to apply for Designation of Manufacturing Community with federal Economic Development Administration. CEQA: Not a Project, File No. PP10-068(c), Policy change that involves no changes to the physical environment. (Economic Development)

Council Member Herrera pointed out that moving forward with this application will provide the City of San José an opportunity to be designated as part of the manufacturing community with the Federal Economic Development Administration.

Assistant to the City Manager/Senior Business Development Manager Chris Burton responded to questions from Council Member Herrera.

Action: Upon motion by Council Member Herrera, seconded by Vice Mayor Nguyen and carried unanimously, Resolution No. 76938, entitled: “A Resolution of the Council of the City of San José Authorizing the City Manager or His Designee to Apply for a Designation of Manufacturing Community with the Federal Economic Development Administration of the U.S. Department of Commerce”, was adopted. (11-0.)

2.8 Authorize the City Manager to:

(a) **Execute purchase orders for Citywide Tree Management and Maintenance Services with West Coast Arborists (San José, CA), Commercial Tree Care (Santa Clara, CA) and A-Plus Tree (Concord, CA) for the period beginning March 1, 2014, through February 28, 2016, for a total cumulative compensation not-to-exceed \$1,535,000; and exercise options to extend the term through subsequent purchase orders for up to five twelve month periods, subject to appropriation of funds.**

(b) **Execute purchase orders for Emergency and Routine Tree Maintenance Services with Bay Area Tree Specialists (San José, CA) for the period beginning March 1, 2014, through February 28, 2015, with a total cumulative compensation not-to-exceed of \$310,000; and exercise options to extend the term through subsequent purchase orders for up to four additional twelve month period, subject to appropriation of funds.**

3.5 Conduct a Public Hearing on the FY 2014-2015 Mayor's March Budget Message. CEQA: Not a Project. (Mayor)

Documents Filed: Memorandum from Mayor Reed, dated March 6, 2014, recommending direction to the City Manager to submit a proposed budget for Fiscal Year 2014-2015 that is balanced and guided by the policy direction and framework of priorities outlined in the Mayor's March Budget Message.

Mayor Reed offered opening comments and background on the FY 2014-2015 Mayor's March Budget Message.

Mayor Reed opened the public hearing.

Public Comments: Georgia Bocil, Directing Attorney, Senior Adults League Assistance urged the Council to continue to fund ongoing senior wellness services at all the Community Centers.

Mayor Reed continued the public hearing to March 18, 2014.

3.3 Adopt a Statement of Policy and City Council Questions related to the selection of a prospective Fire Chief as described in the staff memorandum, in compliance with City Charter Section 411.1. CEQA: Not a Project, File No. PP10-069(b), Personnel Related Decisions. (City Manager's Office)

Documents Filed: Memorandum from City Manager Edward K. Shikada, dated February 26, 2014, recommending adoption of a Statement of Policy and City Council Questions related to the selection of a prospective Fire Chief.

Action: Upon motion by Council Member Constant, seconded by Council Member Herrera and carried unanimously, a Statement of Policy and City Council Questions related to the selection of a prospective Fire Chief as described in the staff memorandum, in compliance with City Charter Section 411.1 was adopted. (10-0-1. Absent: Campos.)

3.4 Discussion and acceptance of report on Paid Parental Leave or Family Leave programs. CEQA: Not a Project, File No. PP10-069(a), Staff Reports. (City Manager's Office)

City Manager Edward K. Shikada responded to Council questions and concerns.

Council Member Constant expressed opposition to increasing the cost of employment for a relatively small percentage of employees in an area where there is no demonstrated problem at this time.

Motion: Council Member Rocha moved approval of his memorandum dated March 10, 2014, accepting the Administration's Report on Paid Parental Leave and to direct the City Manager to explore opportunities to provide this benefit for City employees in the future through the development of the workforce management plan which is currently underway. Council Member Kalra seconded the motion.

Council Members Khamis, Liccardo and Oliverio expressed opposition to the motion on the floor.

Public Comments: Esha Menon, Working Partnerships USA, expressed support to the Administration's Report on Paid Parental Leave.

Action: On a call for the question, the motion carried, the memorandum from Council Member Rocha, dated March 10, 2014, was approved, and the Administration's Report on Paid Parental Leave was accepted. The City Manager was directed to explore opportunities to provide this benefit for City employees in the future through the development of the workforce management plan which is currently underway. (7-4. Noes: Constant, Khamis, Liccardo, Oliverio.)

COMMUNITY & ECONOMIC DEVELOPMENT

- 4.1 As recommended by the Community and Economic Development Committee on February 24, 2014, consider approval of the one of two alternative community special events ordinances that would add Chapter 13.14, repeal Chapters 13.12, 13.16 and 13.22, and amend Chapter 13.44 of Title 13 of the San José Municipal Code in order to establish a comprehensive permit process for outdoor special events on or at City streets, parks, paseos and plazas. City Attorney Richard Doyle pointed out that he issued a supplemental memorandum on McCarthy Ranch Property development restrictions and responded to Council questions and concerns.

Motion: Vice Mayor Nguyen moved approval of the memorandum she cosigned with Mayor Reed and Council Members Herrera and Chu, dated March 7, 2014, as described below in “Action”, including the revision from Mayor Reed: the fair market value for the land at \$6.5 million in lieu of \$6 million. Council Member Herrera seconded the motion.

Council Members Chu, Constant and Liccardo expressed support to the motion. Council Members Constant, Campos and Khamis provided meeting disclosures.

Action: On a call for the question, the motion carried unanimously, the memorandum from Mayor Reed, Vice Mayor Nguyen and Council Members Herrera and Chu, dated March 7, 2014, was approved, as amended, with direction to Staff to return to the City Council in August 2014 with a resolution authorizing the City Manager to execute an amendment to the McCarthy Ranch Declaration of Covenants, Conditions & Restrictions (CC&Rs) and Agreement. The amendment should provide a process that would allow early termination of development restrictions on the McCarthy Ranch property upon occurrence of the following conditions: (1) Completion of the biosolids improvements at the Regional Wastewater Treatment Facility and transition to the new biosolids treatment process. (2) Verification that no odor problem exists based on an odor modeling methodology to be determined. (3) Payment of a fair market value for the land the City acquired as part of the transaction or *approximately \$6.5 Million*, whichever is the greater, upon the termination of the CC&Rs. (11-0.)

6.1 Approve an amendment to the Airport Advertising Concession Agreement (“Agreement”) between the City of San José and Clear Channel Outdoor, Inc. to:

- (a) Extend the Agreement an additional three years from July 1, 2017, through June 30, 2020.
- (b) Modify the Minimum Annual Guarantee to \$1,800,000, \$1,900,000 and \$2,000,000 respectively for each year of the extension period.

CEQA: Not a Project, File No. PP10-066(e), Services that involve no physical changes to the environment. (Airport)

Motion: Council Member Constant moved approval of the Staff recommendations. Vice Mayor Nguyen seconded the motion.

Director of Aviation Services Kimberly Becker Aguirre responded to Council questions and concerns.

Council Member Liccardo expressed opposition to the Staff recommendations.

Action: On a call for the question, the motion carried, an amendment to the Airport Advertising Concession Agreement between the City of San José and Clear Channel Outdoor, Inc. to Extend the Agreement an additional three years from July 1, 2017, through June 30, 2020 and to modify the Minimum Annual Guarantee to \$1,800,000, \$1,900,000 and \$2,000,000 respectively for each year of the extension period, were approved. (10-1. Noes: Liccardo.)

- (2) Gary Farfan commented on public safety and pointed out that the City of San José needs more full time police officers.
