<u>Motion</u>: Councilmember Liccardo moved approval of option "B" to call for a Special Election to be held on April 7, 2015 and a runoff, if necessary, on June 23, 2015, and to defer an interim appointment for the District 4 vacancy until December 9, 2014 unless otherwise instructed by the Open Rules and Government Committee. Vice Mayor Nguyen seconded the motion.

City Clerk Toni J. Taber, CMC, and City Attorney Richard Doyle further clarified the process.

<u>Documents Filed</u>: (1) Memorandum from City Clerk Toni Taber, dated November 20, 2014, transmitting the recommendations of the Community and Economic Development Committee. (2) Supplemental memorandum from Director of Economic Development/Chief Strategist Kim Walesh and Director of Planning, Building and Code Enforcement, Harry Freitas, dated November 20, 2014, providing additional analysis supporting the recommendation.

Director of Economic Development/Chief Strategist Kim Walesh outlined the proposal as presented to the Community and Economic Development Committee, and Council discussion followed.

<u>Motion</u>: Councilmember Liccardo moved approval of the staff's recommendations. Councilmember Herrera seconded the motion.

<u>Substitute Motion</u>: Councilmember Campos moved approval of staff's recommendation with direction to staff to provide an analysis on requirements for pursuing local preferences for contractors. The motion was seconded by Councilmember Kalra.

Councilmember Rocha requested to amend the substitute motion by moving ahead on pursuing local preferences and returning to Council at a later date. Councilmembers Campos and Kalra accepted the amendment.

<u>Public Comment</u>: Offering support to pursuing local preferences were Ross Signorino and Scott Knies. David Wall spoke in opposition to tax breaks.

Action: On a call for the question, the substitute motion carried unanimously, and Staff recommendations to draft an ordinance amending Chapter 4.46 of Title of the San José Municipal Code and Chapter 4.47 of Title 4 of the San José Municipal Code to add sections to suspend the collection of the building and structure constructions tax for a single commercial high rise development project within two years were accepted, with direction to staff to provide an analysis on requirements for pursuing local preferences for contractors, to moving ahead on pursuing local preferences, and with staff to return to Council in late January or early February for final action. (9-0-1. Absent: Constant.)

- 4.2 (a) Per Council Direction from June 17, 2014, direct the City Attorney to draft a resolution to establish a new Downtown High-Rise and Mid-Rise Park Fee Incentive program to allow high-rise developers to pay 50% of their parkland in-lieu fees at certificate of occupancy, and to make a payment equivalent to the remaining 50% of the fee over a 5 year period; and allow mid-rise developers to pay 75% of their fee at certificate of occupancy and to make a payment equivalent to the remaining 25% of the fees over a 5 year period, with the latter payments to be set aside in a fund for downtown parks operations and maintenance;
  - (b) Provide policy direction to staff for the next step to be taken in the development of a potential downtown parks district.

- 7.3 (a) Conduct a Public Hearing on the applications of the following companies for Commercial Solid Waste and Recyclables Collection Franchises for the non-exclusive collection and transport of residential clean-out material and construction and demolition debris;
  - (b) Approve ordinances granting the franchises;
