The motion was seconded by Council Member Kalra.

Mayor Reed suggested that agendization of this item be postponed until the drafting process is complete. Director, Intergovernmental Relations Betsy Shotwell recommended that the item be given more than a one-week turnaround in order to thoroughly vet the issue.

<u>Public Comments</u>: Speaking in support of adopting a resolution to support the Food and Drug Administration's regulation of menthol and flavored tobacco products, were: Dennis Acha (Breathe California), Patsy Ann Cortez, (Menthol Flavored Tobacco Prevention Project), Jason Wilson and Pastor Jeff Moore (NAACP).

Council discussion followed, and April 9, 2013 was discussed as a realistic timeframe to return to Council with this item.

Public Comments: Expressing a need for community collaboration, for developing new strategies, offering comments on authorizing a Nexus study, and offering personal accounts, members of the public included: Jennifer Loving (Destination Home), Evette Lara, Michelle Flores, Israel Lara and Monica Garza (Star of David Ministry); Jenny Niklaus (EHC Life Builders), Louis Chicoine (Abode Services), Sparky Harlan (Bill Wilson Center), Katy Espinoza-Howard (Housing Authority SCC), Brian Greenborg (Inn Vision); Julia Burkhead (Community Technology Alliance), Dana Bainbridge (First Christian Church), Evelyn Stivers (Non-Profit Housing Association), Keri Lung (Mid Pen Housing Corp.), Shannon Brown and Eileen Richardson (Downtown Streets Team); Rich Kizzo, Tina Marsalis, Tony Valladao, Jolene Jones, Poncho Guerrada and Lydia Guel (Sacred Heart); Kevin Zwick (Housing Trust of Santa Clara County), Brian Darrow, Christi Wong and Sandy Perry (CHAM Affordable Housing), Joshua Howard (California Apartment Association), Ross Signorino and Gail Osmer (Colonial Manor). John Davis suggested consequences and a "Bill of Rights" for the homeless, and David Wall spoke on the burden to the taxpayers of San José.

Extensive Council discussion followed.

<u>Motion</u>: Council Member Liccardo moved approval of the memorandum he coauthored with Mayor Reed, Vice Mayor Nguyen and Council Member Rocha. Vice Mayor Nguyen seconded the motion.

Council Member Rocha requested to amend the motion to request the Department of Finance create some continuing source to bond off of, such as bonding against potential development fees. Council Member Liccardo and Vice Mayor Nguyen accepted the amendment.

Director of Planning, Building and Code Enforcement Joseph Horwedel and Director, Intergovernmental Relations Betsy Shotwell responded to questions.

Requests by Council Member Campos and Council Member Khamis to bifurcate the memorandum were declined by the maker of the motion.

Council Member Chu requested to amend the motion to request that staff return during the budget process with an analysis of how to prioritize special needs' groups, such as those that are displaced by domestic violence and military veterans. Council Member Liccardo and Vice Mayor Nguyen accepted the amendment.

Council Member Oliverio requested to amend the motion, requesting that an analysis be made regarding funding for relocation for individuals if needed. Council Member Liccardo and Vice Mayor Nguyen accepted the amendment.

Motion: On a call for the question and carried unanimously, the report was accepted regarding Council questions posed at the November 13, 2012 study session on housing needs and strategies, with further direction to Staff to (1) Explore a possible bond issue with Finance regarding creating some continuing source to bond off of, such as bonding against potential development fees; (2) Return during the budget process with an analysis of how to prioritize special needs' groups, such as those that are displaced by domestic violence and military veterans; (3) Provide an analysis of allowing an option of funding for relocation, if that best serves an individuals' needs. (10-0-1. Absent: Constant.)

 - (e) Amend various Sections Of Chapter 23.04 Part 2, Downtown Sign Zone, including to amend Types Of Signs Section 23.04.120 to allow Flat-Mounted Signs to be placed no higher than sixty (60) feet above grade on wholly nonresidential buildings at least one hundred forty (140) feet in height above grade; and add Safety Or Directional Sign for Public Parking Garages as Programmable Electronic Signs;

Director of Planning, Building and Code Enforcement Joseph Horwedel, provided an overview of actions recommended related to amending Title 23, the Sign Code.

<u>Public Comments</u>: (1) Bob Kieve offered support to the recommendations provided in the March 8, 2013 memorandum of Vice Mayor Nguyen and Council Member Constant. (2) David Wall spoke about electronic billboards.

<u>Motion</u>: Vice Mayor Nguyen moved approval of the memorandum she co-signed with Council Member Constant. Council Member Herrera seconded the motion.

Action: On a call for the question, the motion carried unanimously, and Ordinance No. 29223, entitled: "An Ordinance of the City of San José Amending Several Sections of Chapters 23.02 and 23.04 of Title 23 of the San José Municipal Code to Amend the Definition of a Safety or Directional Sign, to Provide for Signage at Service Stations Pursuant to California Business and Professions Code Section 13531 and to Allow Such Signs to be Programmable Electronic Signs, to Clarify that only Signs that are not Programmable Electronic Signs may be Exempt from the Permit Requirements Set Forth in Section 23.02.1310, to Provide for Safety or Directional Signs for Public Parking Garages and Allow Such Signs to Be Programmable Electronic Signs, to Allow Flat-Mounted Signs to be Placed No Higher Than 60 Feet Above Grade on Buildings Over 140 Feet in Height in the Downtown Sign Zone that Contain Wholly Nonresidential Uses, and to Make Other Clarifying, Ministerial, Technical, Typographical or Other Nonsubstantive Changes to Said Chapters of Title 23", was passed for publication, with direction as provided in the memorandum cosigned by Vice Mayor Nguyen and Council Member Constant dated March 8, 2013, to add a zoning amendment that includes minimum requirements for brightness and size for permanent storefront signage within the Downtown and other commercial sign zones of the City, for any new or expanding business, and direct Staff to return to the Rules and Open Government Committee after 30 days with a progress report. (3) Letter from Jaime Alvarado, Executive Director, SOMOS Mayfair, dated March 12, 2013, offering support to the proposed resolution. (4) Email from Drina Collins, received March 12, 2013, offering support of the resolution.

<u>Public Comments</u>: Offering support to the adoption of a resolution in support of immigration reform were Maria Noel Fernandez (Working Partnerships USA), Jasmin Segura (SIREN), Dennis Raj (South Bay Labor Council), Perla Flores (Community Solutions Consortium), Ross Signorino, Pam Gudino, Lauren Jacobs (SEIU) and Jo Kenny. Jeff Bedolla questioned how this issue got to Council, and David Wall contested the issue as 'harboring illegal aliens'.

<u>Motion</u>: Council Member Campos moved approval of the memorandum he cosigned with Council Member Rocha. Council Member Rocha seconded the motion.

Council Member Khamis requested to amend the motion to reflect the inclusion of a reference reforming the current green card and H-1B visa system. The amendment was accepted by Council Members Campos and Rocha.

Action: On a call for the question, the motion carried, Resolution No. 76573, entitled: "A Resolution of the Council of the City of San José Urging the 113th Congress to Swiftly Enact Comprehensive Immigration Reform that Includes the Following Elements: (1) A Plan for Providing a Clear, Fair and Affordable Path to Citizenship for Undocumented Immigrant Who Are Currently Residing in the United States, (2) the Reformation of the Visa System so that Families May Stay and be Together Both During and After the Process and Workers are Offered Permanent Resident Status or Portable Visas Which Will Provide Certainty and Mobility Meet the Needs of a Growing and Innovative Workforce and Also Recognizes the Aspiration of Immigrants to Build a Better Life, Better Businesses and Thus a Better Community, City and Country with their Contributions, (3) Prioritizing Immigrant Integration into Our Communities and City so that They May Contribute at a Higher Level than Currently Possible Given the Discrimination and Legal Ramifications that They Face Under the Current System, and (4) Respect for the Due Process of Everyone in the United States", was adopted, with the inclusion of a reference to reforming the current Green Card and H-1B visa system to allow Silicon Valley's driving industries to compete successfully for global talent and meet workforce demands. (8-1-2. Noes: Oliverio. Absent: Chu, Constant.)
