COMMUNITY & ECONOMIC DEVELOPMENT

 - (a) An Incentive Agreement between the City of San José and Samsung Semiconductor, Inc. outlining the City and State incentives to be provided to Samsung in coordination with the development of the proposed Research and Development (R&D) Center in North San José.
 - (b) A Capital Equipment and Assistance Agreement with Samsung Semiconductor, Inc., in which the City will provide an amount not to exceed \$500,000 for the acquisition of production and assembly equipment to be installed at Samsung Semiconductor's new R&D facility in San José.

- 9.1 (b) Authorizing, subject to the approval of the Oversight Board and DOF, the execution and delivery, in substantially final form, of an Amended Letter Agreement regarding fees and charges for the Letters of Credit provided by JPMorgan under the Reimbursement Agreement in the amount of 2.80% of the aggregate outstanding face amounts of the Letters of Credit, assuming that two of the three ratings assigned by Fitch, Moody's or Standard & Poor's on the senior lien Redevelopment Agency of the City of San José Merged Area Redevelopment Project Tax Allocation Bonds are not withdrawn, suspended or otherwise become unavailable.
 - (c) Authorizing, subject to the approval of the Oversight Board and DOF, the execution and delivery, in substantially final form, of a Second Supplemental Indenture of Trust relating to the 1996 Bonds between the Successor Agency and U.S. Bank National Association, as Trustee (the "1996 Trustee").
 - (d) Authorizing, subject to the approval of the Oversight Board and DOF, the execution and delivery, in substantially final form, of a First Supplemental Indenture of Trust relating to the 2003 Bonds between the Successor Agency, U.S. Bank National Association as Trustee (the "2003 Trustee) and the 1996 Trustee.
 - (e) Appointing U.S. Bancorp ("U.S. Bancorp") as Remarketing Agent for the 1996 Series B Bonds and Citigroup Global Markets Inc. ("Citigroup") as Remarketing Agent for the 2003 Series B, in each case to replace Bank of America Merrill Lynch.
 - (f) Authorizing, subject to the approval of the Oversight Board and DOF, the execution and delivery, in substantially final form, of Amended and Restated Remarketing Agreements with Citigroup and U.S. Bancorp with respect to the 1996 Bonds and JPMorgan and Citigroup with respect to the 2003 Bonds.
 - (g) Authorizing, the execution and delivery, in substantially final form, of a Remarketing Memorandum with respect to the 1996 Bonds and 2003 Bonds.
 - (h) Authorizing the Executive Officer of the Successor Agency, the Director of Finance of the City of the City of San José, or their designee, to take any actions and execute any and all documents necessary to complete this transaction.
