Mr. Fong submitted twenty one complaints from small business owners protesting the garbage rate increase. Gil Cheso, Republic Services, provided explanations to the speakers and replied to Council concerns.

Mayor Reed closed the Public Hearing.

Council Member Campos provided meeting disclosures.

Director of Environmental Services Kerrie Romanow and Assistant City Manager Edward K. Shikada responded to Council questions.

Extensive Council discussion ensued.

Council Member Liccardo requested that Staff issue an information memorandum to the Mayor and Council Members explaining the rate increase, citing the issues discussed today and providing more detailed information that each District may pass on to their constituents.

Action: Upon motion by Council Member Rocha, seconded by Council Member Constant and carried unanimously, the Second Amendment to the Commercial Solid Waste and Recyclable Material Collection Franchises Agreement with Allied Waste Services of North America, LLC, dba Republic Services, to change the maximum service rate adjustment methodology was approved and Resolution No. 76644, entitled: "A Resolution of the Council of the City of San José Fixing and Determining Maximum Commercial Solid Waste Service Rates in the City of San José Pursuant to the Commercial Solid Waste and Recyclable Materials Collection Franchises Agreement Between the City of San José and Allied Waste Services of North America, LLC dba Allied Waste Services of Santa Clara County Including the Total Processing Fee for Organics Processing Services, Effective July 1, 2013", was adopted. (11-0.)
