**MINUTES OF THE JOINT CITY COUNCIL

Mayor Reed and Supervisor Shirakawa presented introductory remarks.

**INTRODUCTION OF COUNTY/CITY STAFF**

City Manager Debra Figone and County Executive Jeffrey V. Smith offered introductions of Staff.

## **DISCUSSION**

### **Realignment of AB109 and the County Re-Entry Program**

Sheila Mitchell, County of Santa Clara Chief of Probation presented the report on the Realignment of AB109 and the County Re-Entry Program.

Chief of Police Christopher M. Moore presented comments and pointed out that local law enforcement should be involved in this process. Chief Moore stated it is a funding challenge with the current resources and added his belief that the program should continue to work more towards the model of the Mayor's Gang Prevention Task Force.

Discussion ensued.

### **City and County Partnership to End Chronic Homelessness**

Director of Housing Leslye Corsiglia, Emily Harrison, Deputy County Executive and Jennifer Loving, Director of Destination: Home presented the report on the City/County Partnership to End Chronic Homelessness and responded to questions and concerns.

### **San José Downtown Health Center Clinic**

Assistant Director of Planning, Building and Code Enforcement Laurel Prevetti and Ron Johnson, Capital Programs Manager presented the report on the San José Downtown Health Center Clinic and responded to questions.

### **Public Comments**

- (1) Sparky Harlan, Bill Wilson Center, asked for the help of the City and the County to allow the Bill Wilson Center to take on the lead for the youth homeless portion.
- (2) David Wall urged the City and the County to invite the help of the United States Military because the homeless issue is an emergency.
- (3) Kathy Espinoza-Howard, Chair of the Santa Clara Housing Authority, stated that the Housing Authority will continue to partner with the City and the County and are definitely open to ideas from the community and stakeholders in facing this dilemma.
