- Katja Irvin spoke about the Sierra's Club concern with the project being developed near streams
- Linda Ruthruff asked the Commission to remove the idea of a light tower from consideration
- Keith Wandry questioned if a light tower should be considered as iconic, sighting examples of other light towers
- Jean Dresden shared Arena Green is the only treed area in San Jose and mentioned there has been no discussion regarding the potential removal of
