<u>Action</u>: Upon motion by Commissioner Mandair to elect Commissioner Flores for the position of Chair, seconded by Commissioner Adas, the motion carried unanimously. Commissioner Flores was elected Chair. (11-0.)

The nominating committee was not unanimous in their recommendation for Vice Chair and a paper ballot was distributed with the names of the two Commissioners who expressed interested in holding the seat, Commissioners Lovely and Woolfe. Teresa Meyer-Calvert, Recording Secretary, tallied the ballots resulting in a 7-4 vote in favor of Commissioner Woolfe for the position of Vice Chair.

<u>Action</u>: Commissioner Mandair motioned to elect Commissioner Woolfe for the position of Vice Chair, which was seconded by Commissioner Brooks-Immel. The motion passed. (9-1-1) Noes: Lovely; Abstain: Dougherty

Justin Long, Deputy Director of Parks, noted that Parks staff will reconcile the Commission's work plan items with the PRC 2018-2019 Draft Work Plan. This item will be agendized for a future meeting.
